IN MEMORY OF REV. MAX WALKER



Bro. Max was born in Gibson County on January 16, 1939 and went to be with our Lord on August 29, 2018. He was married to Ann Thomas Walker for 57 years, and had two daughters, and a number of grandchildren. He was a graduate of Gibson High School where he was an outstanding basketball player, for which he was later inducted into the Gibson County Basketball Hall of Fame.

Bro. Max was called to preach at the age of 14. He graduated from Union University and New Orleans Baptist Theological Seminary. He served as pastor of Lavinia Baptist Church, Bardwell Baptist in Kentucky, Newbern First Baptist Church and Selmer First Baptist Church. He pastored Selmer FBC for 22 and was named Pastor Emeritus in 2011. He wrote a gospel track entitled "Someone Is

Knocking at Your Heart's Door" which was published by the Tennessee Baptist Convention and used widely. He served on various boards and committees with the Tennessee Baptist Convention and was a trustee on the board at Union University. Most recently he served several churches as interim pastor.

Bro. Jerry W. Smith was born December 10, 1937, and went to be with the Lord on April 7, 2018. He pastored the following churches: Bethlehem Baptist Church-Greenfield, Oak Grove Baptist Church-Milan, Northside Baptist Church-Milan, and Meridian Baptist Church-Jackson.

He was actively pastoring the Calvary Baptist Church in Rutherford up until his death. He was married to his first wife Patsy for 55 years and they had two daughters, Beverly Dodd and Teresa Smith. He was recently married to Patricia Hurt Smith of Kenton.

Bro. John Adams has been married to his wife, Robbie, for 60 years. They have two daughters, two granddaughters and six great grandchildren. He is a graduate of Union University and New Orleans Baptist Theological Seminary with a Master's Degree and a Doctorate of Ministry. He studied at Peking University, Beijing, China.

WHEREAS, The Tennessee Baptist Convention recognized that as an organization of churches we are not keeping pace with the need to saturate our State and the world with the Gospel, while also seeing a decline in church membership, attendance, decisions for Christ, and baptisms; and

WHEREAS, The Tennessee Baptist Convention while meeting at the annual Summit meeting at Brentwood Baptist Church in November 2014 adopted a vision statement with five objectives to evangelize the lost of our State as well as strengthen our existing churches; and

WHEREAS, The Tennessee Baptist Convention embraced and affirmed these five objectives as performance measures to achieving the ultimate goal stated within the one vision to unify our efforts as a cooperative people for the next ten years until the year 2024; and

WHEREAS, <u>OBJECTIVE 1</u> is seeing at least 50,000 Tennesseans annually saved, baptized and set on the road to discipleship by 2024; and

WHEREAS, OBJECTIVE 2 is having at least 500 Tennessee Baptist churches revitalized by 2024; and

NOW, THEREFORE, BE IT HEREBY RESOLVED that the messengers of the 2018 Annual Meeting of the Gibson Baptist Association also wish to express our grief at the passing of Billy Graham on February 21,

2108, while also wishing to celebrate, honor, and commemorate his life and ministry as a beloved Southern Baptist who traveled the world sharing the good news of Jesus Christ.

RESOLUTION VII PROCLAIMING THE IMPORTANCE OF THE GOLDEN OFFERING FOR TENNESSEE MISSIONS

WHEREAS, the Golden Offering for Tennessee missions is an annual state missions offering that provides invaluable financial support for ministries that help reach Tennesseans for Christ; and

WHEREAS, Tennessee Baptists contributing through the Golden Offering for Tennessee Missions provide support for Tennessee ministries helping to sustain state ministries not funded through the Cooperative Program; and

WHEREAS, the Golden Offering for Tennessee Missions is meeting the human needs through Compassion Ministries, such as Disaster Relief, the Baptist Collegiate Ministry, and so much more; and

WHEREAS, the Tennessee Baptist Mission Board has designated that ten percent of the overall Golden Offering for Tennessee Mission be returned to the local Baptist Association to help fund and further the goals and objectives of the state convention;

NOW, THEREFORE, BE IT HEREBY RESOLVED that the messengers of the 2018 Annual Meeting of the Gibson Baptist Association hereby proclaim the importance of the Golden Offering for Tennessee Missions, and ask that each member church include this week of prayer and offering emphasis into the framework of their church planning calendar each year.

RESOLUTION VIII SUPPORTING THE PASSAGE OF HUMAN TRAFFICKING LAWS BY TENNESSEE LAWMAKERS

WHEREAS, The Bible affirms that God is the author of human life and human life is sacred and worthy of protection (Genesis 9:5-6; Psalm 139:13-16); and

WHEREAS, God has created every person – male and female – in His own image and with equal value and dignity (Genesis 1:26-27); and

WHEREAS, God abhors violence against the weak and defenseless and calls His people to defend the hurt and oppressed (Psalm 82:4), to stand for justice (Psalm 82:3; Proverbs 31:8-9), and to deliver victims of abuse from the hazards of their oppressors (Proverbs 6:17; 24:10-12); and

WHEREAS, God ordains civil government as His servant to us for good (Romans 13:4); and

WHEREAS, the Tennessee Bureau of Investigation has defined Human Trafficking as modern-day slavery that includes the exploitation of people against their will, for profit while only allowing victims little or no pay; and

WHEREAS, Human trafficking is the fastest growing criminalized industry in the world with estimated profits around \$35 billion; and

WHEREAS, there have been documented cases of human trafficking in 85% of Tennessee counties; and

WHEREAS, There exists several federal and state laws concerning Human Trafficking;

NOW, THEREFORE, BE IT HEREBY RESOLVED that the messengers of the 2018 Annual Meeting of the Gibson Baptist Association express our profound desire to eradicate human trafficking in all of its forms and urge Tennessee lawmakers to pass meaningful legislation to strengthen and stiffen penalties for engaging in the victimization of people through any form of human trafficking.

- 32. WMU Report Sheilah Spangler, WMU Director, member, Bethel-Yorkville, said there are 3 aspects of missions, which are: learning about missionaries, mission support by giving and praying and going on mission trips. The WMU Report can be found on pages 42-43.
- 33. Seek Team Steve Littleton, pastor, Gibson, mentioned seeing 50,000 saved annually in Tennessee, the website pray4tn.com and praying for a countywide revival. The Seek team report can be found on pages 44-45.
- 34. Strengthen Team Report David Powell, moderator, said this report contains items about Christian Women's Job Corp., Birth Choice, Men's Ministry, Block Party Wagon, Youth Report, Deacon's Report and Pastor's Conference. They can be found on pages 45-51.
- 35. Congregational Singing Clark Perkins, Salem, led the congregation in the hymns "How Great is Our God' and "How Great Thou Art".
- 36. Budget Discussion/Adoption Julie Griggs, chairperson, member, Bethpage, asked everyone to see the comparison of the 2017-18 budget with the new 2018-19 budget. The new budget has a 2.61% decrease. Cuts were made to ministries. The budget committee recommended the approval of the budget of \$197,591 for next year. The budget was accepted.
- 37. Director of Missions Report Roger Stacy, DOM, member, Connect, gave his report. He said that the Minute Books for 2018 would be dedicated to Rev. Max Walker, Rev. Jerry Smith, and Dr, John Adams. He also talked about all of the things the GBA accomplished this year.

- 39. Missionary/Evangelism Message Dr. David Evans, TBMB evangelism specialist, was the guest speaker. He said in his message that we cannot unhitch from the Old Testament. We understand the doctrine included in it. He told the messengers they had to take the gospel to places on their hearts. We need an obsession with Jesus in all our thoughts. He also said we were to be the feet who bear the good news to others.

- 41. Introduction of new pastors—Bro. Roger asked all new pastors to GBA to stand and be recognized.

EXECUTIVE BOARD REPORT

The Executive Board of the Gibson Baptist Association is composed of one elected representative from each church and the pastor of the church. The Constitution and Bylaws require the board to meet quarterly. The Executive Board has as its purpose to conduct the business of the association between annual meetings.

January Executive Board Meeting highlights:

At the January meeting, twenty-nine (29) Executive Board members representing twenty-three (23) churches were present. Special guest, Lewis McMullen, Tennessee Baptist Mission Board Report, and Church Planting Strategist, shared with the board about an interest free loan made available for new church plants. He shared how TBMB has helped with the re-plant of Connect Baptist Church of Milan. Bro Roger Stacy, DOM, shared about his trip to the Holy Land in January with Union University. The board voted to be a co-sponsor to refinance a loan for Connect with the Tennessee Baptist Foundation. Bro Mike Sanders promoted the Evangelism Rally on April 7 at Union University. He also shared he is organizing buses to help people attend Southern Baptist Convention in Dallas, Texas in June. Bob Moore promoted the GBA men's ministry event at FBC Trenton in March with special guest speaker, H.K. Derryberry.

April Executive Board Meeting highlights:

There were twenty-one (21) members at Executive Board April meeting, representing sixteen (16) churches. Jim Acree, treasurer, reported that at end of February we were behind \$6,000 in our budget. Bro. Roger Stacy, DOM, shared about the first GBA bi-vocational retreat held in February at Linden Valley Conference Center with 30 pastors and wives in attendance. He announced a trip to Israel in 2019. He recently attended the Renovate Boot Camp at Linden Valley. Sheilah Spangler, GBA WMU Director, promoted the National Day of Prayer in May with Sheriff Paul Thomas as the speaker. Bro. Mike Sanders, Seek Team Leader, promoted the upcoming GBA Evangelism Prayer Rally with Dr. Greg Frizzell. Doug Duncan, Send Team member, recommended changes to the Wingo guidelines to increase scholarship amounts for volunteers. Dr. Chris Alexander, Strengthen Team Leader, reported there were twenty-four participants in the Bible Drills.

July Executive Board Meeting highlights:

At the July Executive Board meeting twenty-four (24) members representing seventeen (17) churches were in attendance. Jim Acree, treasurer, shared that the association was about \$10,000 behind in receipts, and the balance was down \$6,000 from where we started in October of this year, Bro. Roger Stacy, DOM, shared about the clean up after the storm at the association office, and thanked the pastors and lay people who came to help. He also shared that the Southern Baptist Association had suggested a title change from Director of Missions (DOM) to Association Mission Strategist (AMS). The Association sponsored a Youth night at the Gibson County Fair this year. This was a platform for us to share the gospel with the youth. A praise band and special speaker presented the gospel. Bro. Roger also said due to a new law and regulations, plus the cost in fees, the Tennessee Baptist Convention recommended that associations no longer use bouncy houses on their block party wagons. The Board approved two items: Due to a shortage of funds for lawn care, funds were approved for transfer from Contingency Reserve. The other item approved was a change of date and location of the annual meeting from October 22 to October 29. The new location will be Salem Baptist Church. Christy Skelton, CWJC director, informed the board that Twice Blessed thrift store had moved to the Carol's Antique Mall building, Juliana Wilson, TN WMU specialist, was a guest speaker and shared about the Golden Offering for Tennessee Missions. She stated that 100% of the Golden Offering stays in the state of Tennessee. She also informed the board that GBA receives 10% of what is given to the offering back to our association to use for local missions. Bro. Andy King, Send Team leader, gave the Send Team Report. He informed the board that some of the Golden Offering funds were used to help with Connect Church this year and will be used again this year as the work continues to develop and grow.

DIRECTOR OF MISSIONS REPORT (ASSOCIATIONAL MISSIONARY)

I want to begin my report by thanking this association for allowing me to serve you these eleven and a half years (11 ½). I also want to thank Dianne Klutts for her dedicated service and help as our ministry specialist.

I cannot begin to describe the experience of walking where Jesus walked. About twenty-five Directors of Missions were provided a free trip to Israel thanks to Union University and the Tennessee Baptist Convention.

Thanks to the provisions in the budget through the Strengthen Team, some eight couples participated in the Tennessee Baptist Bivocational Minister and Wives Retreat in Pigeon Forge. Through the ministry plan of the Strengthen Team, funds were provided to scholarship six pastors. We held our first GBA Bivocational Pastors and Wives Retreat the weekend of February 16-17. Bro. Danny Sinquefield and his wife Rhonda led the retreat at Linden Valley.

In April, I attended the Renovate Boot Camp for church revitalization. The Tennessee Baptist Mission Board sponsored the training. Dr. Tom Cheyney, founder of Renovate National Church Revitalization from Orlando, Florida, led the training.

I participated in the planning for our Evangelism Prayer Conference with Dr. Greg Frizzell in April. Two sessions were held over the weekend with Dyer FBC and Milan FBC hosting these two events.

In May, I participated in the National Day of Prayer held at the Yorkville Community Center. Sheriff Paul Thomas was the keynote speaker.

In June, I attended the Southern Baptist Convention in Dallas, Texas. At that meeting, a study committee recommended to the Southern Baptist Conference of Associational Leaders (DOMs) a change of name for Directors of Missions. The organization unanimously adopted "Associational Mission Strategist" (AMS). This decision is not binding on any association, as we are an autonomous body and not dictated by any group or entity

In August, we held our first Youth Night at the Gibson County Fair. The Fair reached out to us and asked if we would provide a program to our youth. I also attended the Senior Adult gatherings in the spring and in the summer this year.

In September, White Hall hosted the GBA annual Deacons' Meetin' with the focus on bringing pastors, staff, deacons and their wives together for fellowship and a challenging message.

I have continued to work with the Seek Team and Strengthen Team to help with the re-start and replanting of Connect Church in Milan. This has been a great associational effort to revitalize this work. The church now has a pastor, Bro. Keith Donaldson, and is growing. A number of churches have committed to participate financially, either monthly, quarterly or yearly to help get this work up and going. Golden Offering funds designated for missions and evangelism have helped to support the work as well. I want to strongly encourage every church to give to the Golden Offering for Tennessee Missions. Every association receives ten percent (10%) back from the total amount given by that association.

We continue to send mission teams to work in our sister association in Ohio with the West Central Baptist Association. The need remains great to help this association reach the lost and plant churches. Through the Wingo funds, this year we have send mission teams to Romania, Ecuador, Brazil, India and other places in the world.

2018-2019 GUIDELINES FOR WINGO MISSION FUNDS

In order to receive Wingo Funds for any mission trip or project, all volunteers must undergo a background check with the GBA. This requirement is in compliance with our mission sending agencies of the Southern Baptist Convention, and is for the legal prudence of the GBA. No funds will be dispersed for any trip or project until the background screening requirements are completed and payment has been received.

BACKGROUND SCREENING REQUIREMENTS

- 1) Volunteers must submit three references using the reference forms provided by the GBA. The references must be from individuals who are not family members of the volunteers and must be at least 21 years of age. One of the three references must be from the pastor of the church where the volunteer is a member. In cases where the church is without a pastor, a staff member or chairman of deacons may serve4 as a reference.
- 2) Volunteers must complete a personal interview questionnaire form provided by the GBA.
- 3) Volunteers under the age of 18 are only required to submit reference forms and the personal interview questionnaire.
- 4) Volunteers who are older than 18 must have a background check through the company used by the GBA. A consent form will be provided for the volunteer to grant permission for the background check.
- 5) The volunteer will be responsible for paying the fee for the background check.
- 6) Volunteers are required to watch a child protection video provided by the GBA.
- 7) Volunteers are required to undergo background screening every four years with the GBA.

INTERNATIONAL MISSIONS PROJECTS

GBA Volunteers and churches participating in an official project of the Gibson Baptist Association, the Tennessee Baptist Convention, or the International Mission Board are eligible for travel assistance from the Wingo Fund account. Scholarships from this account primarily seek to encourage and help GBA volunteers (ages 15 and older or a student who has completed 9th grade) to participate in a 'first time' mission trip. The following guidelines apply for use of Wingo Funds:

- 1) Funds are designed to assist volunteers who participate in an official IMB trip/project. First time international mission volunteers are eligible for a scholarship of \$400.
- 2) Volunteers who have previously participated in an official IMB project/trip are eligible for a \$300 scholarship once per associational calendar year, if it is an IMB project/trip.
- 3) Churches may request a multiple scholarship for volunteer team members of the same church once in the calendar year.
 - * A multiple scholarship is designated when a group of volunteers from a single church are participating in the same project/trip.
 - * A multiple scholarship amount will be limited to \$2,000 for the project/trip.
 - * Only one multiple scholarship can be granted to a single church in the calendar year.
 - * Additional scholarships may be awarded to other individuals of a church that has received a multiple scholarship (under existing guideline) up to \$1,000 over and above the multiple scholarship.
 - * Scholarship requests that exceed the \$3,000 limit for a church may be considered by the Send Team.
 - * It is encouraged that first time volunteers be distributed their full \$400 scholarship from this amount, if possible.
- 4) Volunteers (first time or otherwise) not participating in a multiple scholarship project/trip with their church are still eligible for an individual scholarship once during the association calendar year.
- 5) Volunteers requesting funds must complete an application which is available at the GBA office or by email.
- 6) Wingo funds will be disbursed as early as possible with adequate notice prior to the date of the project/trip. Special considerations may be submitted to GBA.
- 7) Any special requests/needs for funds not addressed in these guidelines may be addressed to the necessary channel of the Send Team.
- 8) In order to help and encourage pastors who have never participated in an IMB international mission trip while serving as a GBA pastor, a \$ 1,000 pastor's scholarship will be available for five pastors each year (first come, first serve basis). To qualify, this must be the pastor's first IMB international mission trip as a GBA pastor. The pastor will still be eligible to receive Wingo funds for first-time mission volunteers along with this scholarship. It must be an official trip of the International Mission Board and be in compliance with all guidelines for Wingo mission funds.

DISASTER RELIEF PROJECTS

1) International disaster relief projects will qualify for travel assistance for GBA volunteers as listed above. However, for International Disaster Relief Projects, the minimum amount from this fund shall be \$500 for any volunteer from GBA, regardless of the number of trips/projects the volunteer may have participated in.

2) Matching funds from the local church is encouraged.

3) The maximum total contribution to volunteers from a single church for any specific project/trip travel assistance is \$2,000.

4) USA disaster relief projects qualify for gasoline reimbursement for volunteers from GBA going to a disaster point as called upon by the GBA or TBC.

5) An allocation of up to \$1,000 may be given to any area where a disaster has occurred. The gift and amount is to be determined by the Send Team of the association.

NORTH AMERICAN MISSIONS PROJECTS

GBA Volunteers and churches participating in an official project of the Gibson Baptist Association, the Tennessee Baptist Convention, or the North American Mission Board are eligible for travel assistance from the Wingo Fund account. Scholarships from this account primarily seek to encourage and help GBA volunteers (ages 13 and older or a student who has completed 7th grade) to participate in a 'first time' mission trip. The following guidelines apply for use of Wingo Funds:

1) Funds are designed to assist volunteers who participate in an official GBA, TBC, or NAMB trip/project more than 200 miles round trip from the Gibson Baptist Association Office out of state. First Time North American mission volunteers are eligible for a scholarship of \$150.

2) Volunteers who have previously participated in an official North American Mission project/trip are eligible for a \$100 scholarship once per associational calendar year, if it is a North American Mission project/trip.

3) Churches may request a multiple scholarship for volunteer team members of the same church once in the calendar year.

* A multiple scholarship is designated when a group of volunteers from a single church are participating in the same project/trip.

* A multiple scholarship amount will be limited to \$1,000 for the project/trip.

* Only one multiple scholarship can be granted to a single church in the calendar year.

Additional scholarships may be awarded to other individuals of a church that has received a multiple scholarship (under existing guideline) up to \$375 over and above the multiple scholarship.

Scholarship requests that exceed the \$1.375 limit for a church may be considered by the Send

Team.

* It is encouraged that first time volunteers be distributed their full \$150 scholarship from this amount, if possible.

4) Volunteers (first time or otherwise) not participating in a multiple scholarship project/trip with their church are still eligible for an individual scholarship once during the association calendar year.

5) Volunteers requesting funds must complete an application which is available at the GBA office or by e-

6) Wingo funds will be disbursed as early as possible with adequate notice prior to the date of the project/trip. Special considerations may be submitted to GBA.

7) Any special requests/needs for funds not addressed in these guidelines may be addressed to the necessary channel of the Send Team.

WINGO OFFERING

Each year the Send Team of the association will recommend a goal for the Wingo Offering at the Annual Meeting of the GBA. Gifts from churches or individuals for these accounts are welcomed anytime during the budget year. However, a recommended date for receiving the Wingo Offering in the churches is the last Sunday of each month, May through September each year. Fund allocations from donations/offerings will be determined by the Send Team each year. The Wingo Offering is named in honor of Rev. Charles Wingo, first Director of Missions, GBA. Wingo Funds exist to encourage volunteers and church participation.

SEND TEAM REPORTS

WINGO FUND REPORT

In 2017 - 2018 GBA churches and individuals gave \$18,113.12 towards the 2017-18 Wingo offering goal of \$22,500. This assists a variety of mission projects during the year. This amount was \$4,386.88 short of the goal. Last year our churches gave \$27,756.32 toward the 2016-17 goal. At the 2017-18 Annual Meeting the Wingo Offering total was \$1,354.00 which brought the Wingo Offering grand total to \$19,467.12. As an association, we celebrate the sacrifice that individuals and churches have made to help us as we strive for the goal.

In 2017-18 Wingo Funds were used to help sixty (60) individuals from fourteen (14) GBA churches receive scholarship assistance through the Wingo Funds to help them bear the cost of their mission trip to five (5) different countries. Last year fifty-three (53) individuals from twelve (12) churches used the Wingo Funds to help go to three (3) countries.

BRAZIL MISSION REPORT

Our partnership with the International Mission Board as a virtual missionary to Brazil continues to be strong and blessed. We have submitted our Ministry Plan to IMB and have their approval for serving as an associational mission strategist (virtual missionary) to help plant churches, strengthen new works, and encourage existing works.

This past year volunteer teams have worked in several cities and seen God's hand upon the work. In November-December, a team served in Foz do Iguaçu (Iguassu Falls) with pastor Flávio to help a mission church reach the lost, disciple the new converts, and then organize into a church shortly after the team departed. The team saw 169 people profess Christ as their personal Lord and Savior. Team members preached in churches and shared songs and testimonies. The team also worked with Journey Baptist Church, a new church plant. This is the church that was planted by the Gibson Baptist Association and volunteer teams. The GBA bought the land and the Brazilian Baptist Men built the church building.

A team of volunteers worked in Rio de Janeiro in March. The crime syndicate and the drug cartel controlled the area where the team worked. Pastor Douglas Xavier has worked this area for twenty-five years and secured our safe passage into the area and our safety. God blessed the work with 239 souls being saved and discipled. Pastor Douglas has asked that we partner with him to send more teams to this area to reach Brazilians and plant churches.

In June, another team of volunteers returned to Rio de Janeiro and worked with Pastor Douglas Xavier in the favela area controlled by the drug lords and crime syndicate. Our team consisted of several youth that God used tremendously to share the gospel in public schools. Once again the team had to be escorted in and out of the area under the supervision of the pastor who secured permission from the criminal elements and guaranteed our security. God blessed our team and 129 professions of faith were made. One of the greatest blessings was to see people who were saved the previous year when our team was in the area. These discipled converts are now participating in church and are firm in their commitments to the Lord.

In September, a team worked near the city of Iguassu Falls, twenty-five minutes north in a city named São Miguel does Iguaçu. This city is in the metropolitan area of Iguassu Falls, which has a population of around 270,000 people and only seven (7) Baptist churches. The team worked with Pastor Dilson Neto to help rebuild the work. The church had been a strong church but has suffered the loss of many members due to a split. Our team was asked to help reach lost people, disciple them, and help the church reclaim the city for Christ. God blessed with 122 professions of faith in Jesus, and many discipled new believers.

OHIO MISSION REPORT

We continued with our connection to the West Central Baptist Association this year. The challenge still remains to reach their ten (10) counties and over 550,000 residents. This association has only 14 Southern Baptist Churches. The need is great to plant more churches and reach the lost.

This past summer, Jonas Mackey, the Youth and Music Pastor at Medina FBC, led a team to Ohio. Jonas provided this report of their work.

As one team, in two vehicles, with a seven-disc road trip music mix, Medina FBC hit the road this summer on our journey to FBC Marysville, OH. While praying about what the Lord would have us do and where He would have us go for our summer mission trip this year, I came across an update from Brother Roger. He was asking for churches willing to form teams and travel to our partner association in Marysville to contact him, so, we reached out.

We would spend the next weeks and months getting in contact with their Director of Missions who eventually put us in contact with Pastor Pete Hamilton and FBC Marysville. The Lord led us to put on a week-long VBS in the mornings, afternoon sports games at the neighboring park, and small series of revival meetings in the evening. Additionally, since our trip was the week of July 4th, we were able to hand out a few hundred water bottles at their city-wide parade.

Our team was blessed to see the Lord working in the lives of each of our members while we were there, in the lives of the students who came to the VBS, and the lives of their members who attended the various services throughout the week too. We have since heard some positive reports of the impact of God's work in at least two families who were not previously connected to the church, or the Gospel for that matter, through ministries and people of FBC Marysville. Christ blessed His work ahead of us, during our time there, and since our departure, and for this we are truly thankful. All glory and praise to Him, and Him alone.

Consider now that in this upcoming year you and your church will send a team to work in Ohio.

GIBSON BAPTIST ASSOCIATION WMU

WMU, at the associational level and in every church, has been very active this year.

Over 51 Law Enforcement Appreciation baskets were provided by WMU groups; each deputy received one and there were extras for the offices. - 2. To assist GBA Churches to fulfill the Great Commission, GBA continued to partner with Union University on Sunday, March 4th, 2018 for the 3rd Annual "The West Tennessee Evangelism Rally" with Guest Speaker Dr. James Merritt, pastor of Crosspoint Baptist Church from Duluth, Georgia and former president of our Southern Baptist Convention. There were (10) Breakout Sessions in addition to designated groups to high school student's and women's groups having more tools to use in reaching lost people to believe in JESUS CHRIST as their LORD & SAVIOR.
- 3. Evangelism/Prayer Rally On Saturday evening, April 7th & Sunday evening, April 8th, 2018, a evangelism/prayer rally was held at two GBA churches. On Saturday evening we met at Dyer FBC and Dr. Greg Frizzell from Oklahoma City, Oklahoma spoke on the theme "Prayer That Brings Revival and Evangelistic Harvest". Sunday evening the rally was held at Milan FBC with Dr. Frizzell speaking on the theme "The Covenant to Reach Gibson Baptist Association For CHRIST". We are asking each church to consider giving \$500.00 toward this ministry as you prepare for your next ministry plans/budgets!!! EVANGELISM

Thirty-four (34) GBA churches reported baptizing two hundred twenty five (225) people this year. Last year forty-two (42) GBA churches reported baptizing 269 people. We baptized forty four 44) less people this year.

VACATION BIBLE SCHOOL

Vacation Bible School is the most effective tool the church has to reach the lost: Consider the following facts:

- 25% of Baptisms reported by the Southern Baptist Convention comes from VBS.
- Every 1 person trained in VBS results in 1.1 salvation decisions.
- VBS increases the number of prospects discovered from your community
- 10% of people enrolled in VBS are unchurched

The Gibson Baptist Association's Vacation Bible School team participated in the training offered by the Tennessee Baptist Convention in Jackson. The team was composed of members of several of the GBA churches from across the association.

The Association Vacation Bible School Clinic was held this year at Trenton First Baptist Church on Thursday evening, March 22, 2018. There were approximately 50 to 60 participants present for the training with representation from several of our GBA churches. The theme this past year was "Game On." This year thirty-four (34 GBA churches hosted a Vacation Bible School clinic. There was an enrollment of 2,813 on the churches campuses.

MEN'S MINISTRIES REPORT

This year the annual men's ministry event was held at Trenton First Baptist Church. The special guest speaker was HK Derryberry and Jim Bradford from Middle Tennessee. Jim Bradford is the author of a book on the life of HK entitled *The Awakening of HK Derryberry*. The book details the story of how one man was willing to step out of his upper middle-class world into the life of a young, disabled boy with a little hope and not much of a future. Jim had no way of knowing the transformational potential of that friendship—for HK and himself.

HK was born during the sixth month of his mother's pregnancy when she lost her life due to a car wreck. HK's life is truly a miracle. He was born weighing two-pounds and spent the next 96 days fighting for survival in Vanderbilt University Medical Center. Doctors offered little hope of survival but he proved them wrong.

HK graduated from the Tennessee School for the Blind in May of 2013 at age 21 years old. Though blind, he has an unusual memory and remembers any date and the events occurring on that date.

The Strengthen Team will be working with the Men's Ministry leader and restructuring the ministry plans and events for the next year.

BLOCK PARTY WAGON

The Block Party Wagon (BPW) has been a tremendous ministry tool to share the gospel with the lost. Several churches have used the BPW this year to reach their communities for Christ.

Recently, the State of Tennessee passed a law that governs the use of jumpers (bouncy houses). Tennessee now requires companies and non-profit organizations to hire qualified third party inspectors to perform annual inspections of the jumpers (bouncy houses). Inspection reports from qualified third party inspectors are required and inspectors must be certified by one of three (3) approved certifying agencies: (1) the National Association of Amusement Ride Safety Officials (NAARSO), (2) the Amusement Industry Manufacturing and Suppliers (AIMS), and (3) the Association for Challenged Course Technology (ACCT).

In consultation with the leadership at the Tennessee Baptist Convention, the associations and churches have been encouraged to discontinue offering the use of the jumpers (bouncy houses) due to all of the state regulations, costs of inspections and fees to the state of Tennessee, and liability.

As shared at the July Executive Board meeting, the jumpers (bouncy houses) are no longer available for use by our churches.

YOUTH REPORT

The Strengthen Team is responsible for the development of the youth ministry in the Gibson Baptist Association. The past several years, we have had one person serve as the GBA Youth Director and coordinate with other youth leaders and youth pastors to plan the annual See You At The Pole (SYATP) rally.

This year, the Strengthen Team restructured the youth ministry and set up a GBA Youth Ministry Leadership Team composed of the following individuals: Bill Kisner, team leader; Travis Ellis, team member; and Keith Donaldson, team member.

The Gibson County Fair asked the Gibson Baptist Association, Bro. Roger Stacy, DOM, to organize a youth night event at the fair. The GBA Youth Leadership Team planned and coordinated a youth night at the fair on August 29, 2019. Due to the weather, the event was moved to Salem Baptist Church. There were over about 350 people there. Worship was led by 40Save1, and the special speaker for the evening was Jay Barbier, youth specialist with the Tennessee Baptist Mission Board

In light of the Gibson County Fair invitation to hold the GBA Youth Night event, the See You At The Pole Rally was postponed this year. Churches were encouraged to go to their local schools and pray for students and faculty.

SEMINARY EXTENSION REPORT

"Thy word is a lamp unto my feet, and a light unto my path." Psalm 119:105

For the past eleven years, we have offered Seminary Extension as an avenue to help lay people and pastors with ministry skills and knowledge. The theological training has helped them prepare while at the same time remain connected to their current church and ministry. These courses were transferable to several colleges and seminaries if a student desired to continue his or her studies.

Our six Southern Baptist Seminaries launched this program many years ago. Some of our students who have taken these courses have gone on to pursue a bachelor's degree.

The Tennessee Baptist Convention is considering developing a Bible Institute program to help train and develop lay leaders and pastors. Some associations are also offering courses through their own Bible Institutes. The GBA Strengthen team will be considering this possibility of offering courses through a Bible Institute as we move forward with continuing education.

SUNDAY SCHOOL REPORT

For the last several years, the Annual Church Profiles show that Sunday School attendance and enrollment have continued to drop. The annual church profiles for 2017/18 shows that Sunday School enrollment decreased again. Our churches reported a Sunday School enrollment of 6,173 which is a decrease of 330 people from last year's enrollment of 6,503. But our Sunday School average attendance increased by 8 people with the 2017/18 average attendance at 3,912 and the 2016/17 average attendance at 3,904.

GBA has 32 churches reporting between 1-50 in average Sunday School attendance, 10 churches reporting from 50-100 in attendance and 12 churches that report having over 100 in average Sunday School attendance.

DISCIPLESHIP TRAINING REPORT

Discipleship Training has decreased this year from last year. This year seventeen (17) of our churches reported a total enrollment of 1,090 in Discipleship Training. Last year seventeen (17) churches reported an enrollment of 1,145. The enrollment decreased by 55 members.

TENNESSEE BAPTIST CHILDREN'S HOMES

The Tennessee Baptist Children's Homes has been ministering to children who have found themselves in hard places for 127 years! Speaking of 127, James 1:27 says, "Pure and undefiled religion in the sight of our God and Father is this: to visit orphans and widows in their distress, and to keep oneself unstained by the world." It is the mission of TBCH to be obedient to this command of Scripture concerning children who need someone besides their parents to care for them.

As of this writing, TBCH has ministered to 117 different children in **Residential Care** this year. While many of these children still reside on one of our three campuses, 33 children have been successfully reunited with their families, and 2 children have been adopted and placed in a forever family! We have assisted 13 of our young adults as they transition out of our care into adulthood.

To cut our deficit spending, our residential program is now active in three locations: The Ranch @ Millington, The Brentwood Campus, and the Chattanooga Campus. Today, we have beds for 88 children in residential care with the goal over the next year to increase that number to 96. Streamlining to three campuses, while challenging, was a necessary component in our strategic plan to double the number of children we serve at any one time by 2020.

TBCH's **Foster Care** Program has served 108 children and has had 32 sets of Christian parents commit to be Foster Families. Several of these children are in "Foster to Adopt" situations that we are praying will result in more children having permanent homes. Already this year we have had 7 children adopted and placed in a forever family! We are also pleased to announce that our no-cost contract with the State of TN's Department of Children's Services has been renewed for another five years. We are excited about the expansion of our George Shinn Foster Care Program and the continued ability to place children who are in state custody with Christian parents.

TBCH is also excited about the launch of our new ministry called **Family Care** as of June 1, 2018. Kelly Campbell is taking the lead in networking with our churches and other organizations in an effort to support and enable churches, biological families, foster families and adoptive parents to be successful in the task that God has called them to concerning children.

Join us in praising the Lord for the 9 children in our care who have been born again while on our campuses or in one of our foster homes! Through the faithful service of our staff, our foster families, the local church, and by God's grace an eternal impact is being made on the lives of the children who come into the care of TBCH.

Total Impact: The Lord has allowed TBCH the honor of ministering the love of Jesus Christ to a total of 2,418 souls from November 1, 2017 through July 26, 2018. This number reflects the specific individuals that have been affected by the ministry of TBCH including residents and their families, other families we have ministered to through counseling as well as our foster children and their families.

This great work would not be possible without the faithful support of Tennessee Baptists. Thank you for supporting the Cooperative Program and the Mother's Day Offering that directly blesses the children in our care.

TENNESSEE BAPTIST ADULT HOMES

Tennessee Baptist Adult Homes continues to provide a Christian residential ministry for senior adults and for exceptional adults. This ministry is provided in senior adult living communities and in residential group homes in several locations within our great state. The most notable change to the ministry of TBAH during this past year is that we sold the Baptist Health Care Center in Lenoir City. The sweeping changes in the delivery of nursing home care over the past two decades gave rise to the need to sell the facility. Its antiquated architecture and the monumental expenditures that would be required to make it compatibility with newer codes and requirements to make it a Skilled Nursing Facility (SNF).

The proceeds from the sale of the Baptist Health Care Center have been used to retire the debt that had been incurred in the beginning phases of Williams Ferry Pointe, an independent living retirement community adjacent to the health care center. We have been working closely with a developer and with the city to get building started again at Williams Ferry Pointe.

Baptist Village of Johnson City now has a new manager. After serving faithfully for over 20 years as Manager there, Sarah Farmer of Johnson City, retired and Carol Church has been named the new Manager for the location. These duplex homes are for retirees who need affordable housing and the rent is based on income. Preference is given to retired ministers and missionaries.

The Deer Lake Retirement Community in the Bellevue community of Nashville is a 135-condominium unit complex for retirees. These modest duplex homes offer home ownership in an affordable retirement community. TBAH provides a manager for the complex and employs a part-time chaplain for the spiritual care of these independent seniors.

The group home ministry for exceptional adults continues to provide a Christian home for up to 55 men and women who need assistance and supervision. These homes, located in Nashville, Lebanon, Knoxville, and Jacksboro are often a forever home for the individuals who move in. Their diminished intellectual abilities would make them too vulnerable to live alone in the community. These homes provide family. Your generous gifts to the annual Father's Day Offering keeps these homes going.

Finally, the Special Friends Camps were near capacity in attendance this summer. Funded primarily by the Golden Offering for Tennessee Missions, these camps provide at least three things; 1) a week of activities for the campers with intellectual and physical disabilities, 2) a week of respite for the families of the campers who provide care day in and day out at home, and 3) two weeks of rewarding, hard work for the young people who staff the camps...not to mention the life-long friendships these young staffers make as Counselors.

Since 1938 the Tennessee Baptist Foundation has been of service to Tennessee Baptists and Kingdom causes around the world. The assets under management of the Foundation have grown from \$6,577 to \$148 million during that time. God continues to bless this ministry and we are pleased to make our report to the convention as to highlights for the fiscal year 2017-18 thus far. The Foundation is pleased to offer the following services to Tennessee Baptists:

Tennessee Woman's Missionary Union

The WMU emphasis for 2017-18 was "By All Means" based on 1 Cor. 9:22b-23 focused us on challenging Christ followers to follow His example as we step into the world around us, cultivating relationships and creating opportunities to demonstrate the love of Christ.

Highlights from the past year include:

The 2017-18 State Acteens Advisory Panelists were Maegan Adkins, Truett Association; Grace Clouse, Caney Fork Baptist Church, Cookeville; Amanda Huggins, Unaka Avenue Baptist Church, Johnson City; SandiGlen Jones, First Baptist Church Sevierville; and Mia Selvidge, Cedar Fork Baptist Church, Sweetwater.

The theme for the 2017-18 Tennessee Missions Emphasis was "At All Costs Obey." The suggested dates for the Week of Prayer for State Missions was September 10-17 and the goal for the 2017-18 Golden Offering for Tennessee Missions was \$1,925,000. As of July 26, 2018, the total amount given to the 2017-18 Golden Offering is \$1,733,260.46. The offering year goes from September 1 – August 31.

October is always a busy time for children's missions events.

Over the three weekends of JAM, there were 443 participants, from 50 different churches.

At RA Camp-O-Ree, there were 445 campers and adult leaders, plus 167 additional adults serving as volunteers, who led and participated in different activities.

In December, Tennessee WMU mailed, on behalf of Tennessee Baptists:

Checks for \$150 to 22 missionary kids whose parents serve with IMB and are from Tennessee.

Checks for \$50 to 81 retired IMB missionaries, who are from Tennessee.

These gifts are made possible through an allocation from the Golden Offering for Tennessee Missions for nurturing Tennessee missionaries and their families.

Missions Get-Together & Connection were held on March 16-18, 2018 at the Gatlinburg Convention Center with a total attendance of 1,495. The annual offering totaled \$9,475.33 with 90% designated to Tennessee WMU missions efforts in Denver/Front Range; 10% benefited Tennessee WMU Touch Tomorrow Today Endowment at the WMU Foundation. Through the event ministry project, participants brought 521 backpacks filled with school supplies to benefit City Reach: Nashville

Martha Pitts from Germantown Baptist Church was elected to her third term as President, during the Tennessee WMU Annual Meeting on March 17, 2018 at the Gatlinburg Convention Center. Other officers elected for 2018-19 include Recording Secretary, Charlyene Couey, Nashville; and three Vice Presidents, i.e. West: Jeanette West, Memphis; Middle, Colleen Richardson, Livingston; and East, Janice Lewelling, Dunlap.

In March 2018, \$38,400 in scholarships were awarded to 33 students attending graduate school, seminary, as well as, undergraduate schools in Tennessee during the 2018-19 school year. These scholarships are funded through endowments, invested funds and the Golden Offering for Tennessee Missions.

Tennessee WMU sent three Prayer Walking Mission Teams to Denver in 2018 with a total 16 participants.

Currently we have 20 Christian Women's Job Corps and eight Christian Men's Job Corps sites in Tennessee. This Christian based program, seeks to help men and women in breaking the cycle of poverty through job and life skills classes, Bible study, and mentoring. In 2017, Tennessee sites served 1,639 participants with 741 completing the program. We recorded 210 spiritual decisions, which included 40 professions of faith.

In July 2018, four new Literacy Missions volunteers participated in the National Literacy Missions Workshop in Shocco Springs, Alabama. Tennessee Literacy Missions now has five English as a Second Language (ESL) workshop trainers (two in East, two in Middle and one in West), one Adult Reading and Writing workshop trainer and one Tutoring Children and Youth workshop trainer. Together these ministries can bring Tennesseans to Christ, through Literacy Missions.

Currently, Tennessee WMU staff includes Vickie Anderson, Executive Director-Treasurer; Denise Bronaugh, Adult Missions and Ministries Specialist; Juliana Wilson, Communications & Children Missions Specialist; Beth Moore, Student & Literacy Missions Specialist; Vickie Clemons, Administrative Assistant; *vacant*, Ministry Assistant; Brian Holt, RA/Challenger State Coordinator, and Janice Carter, CWJC/CMJC State Coordinator.

Working together to encourage and equip churches, and individuals, to engage in missions learning and involvement that helps them to fulfill the Great Commission.

BAPTIST & REFLECTOR

Striving for excellence has been a key phrase for the *Baptist and Reflector* in 2018. The paper was named by the Baptist Communicators Association as the second best state paper in the Southern Baptist Convention in terms of content and design. In addition, members of the Communications Team (which includes the B&R) of the Tennessee Baptist Mission Board captured several individual awards for material produced related to the paper.

The *B&R* is mailed to nearly 21,000 homes 26 weeks a year, reaching a potential readership of about 52,500 readers.

In addition, the *B&R* website has grown since it was introduced in late 2015. We have had more than 116,000 user engagements since January with 66,212 visitors and 196,553 page views.

The goal of the paper is to "tell the story of Tennessee Baptists" through news, feature stories and photographs. As in the past, the paper this year placed a major emphasis on what Tennessee Baptists are

doing to reach the world for Christ by focusing on stories related to missions and evangelism. This year the paper has focused on timely topics such as domestic violence that impact Tennessee Baptists and our churches.

The *Baptist and Reflector* continued to utilize social media tools in 2018 such as Twitter. Editor Lonnie Wilkey regularly writes a blog that provides information for Tennessee Baptists between print issues. The paper also has a Facebook page that has been more prominent with the addition of David Dawson to the Communications Team.

The staff monitors trends that could affect Tennessee Baptists and prints those stories to keep readers informed. In addition, opinions, both from the editor and others, are printed and are intended to make readers think, reflect, and act.

The paper continually seeks to enlist new subscribers and will be offering a simplified subscription plan in the near future. We need more churches to send the paper to their leadership such as deacons, Sunday School teachers, etc. We are asking every reader of the *B&R* for the next year to consider sending one subscription to someone they know. If just a small percentage of our readers would do this, our print circulation would significantly increase. INTERNATIONAL MISSION BOARD (IMB) REPORT

On behalf of the International Mission Board, I want to thank you, Southern Baptists, for your permanence in the task of fulfilling the Great Commission given by our Lord. Because of your partnership through the IMB, disciples have been made and churches have been multiplied among the nations as we work together for the spread of the gospel around the world.

You have proven your commitment to the Lord's leadership year after year as you continue your faithful financial support through the Lottie Moon Christmas Offering and the Cooperative Program. In 2016, Southern Baptists gave \$153 million through the 2016-17 campaign to support IMB field personnel. As a result of your Lottie Moon gifts, as well as your continual giving to the Cooperative Program, the IMB consistently can operate on a budget that balances our receipts with our expenses.

Within the framework of this balanced budget, in 2017 we celebrated with you the sending of full-time, fully funded mission personnel while we continued to explore and send more missionaries going through new pathways designed to engage students, professionals, retirees, and others as part of our mission force. At the IMB's annual meeting dinner in Phoenix in June, approximately 1,350 Southern Baptists in attendance estimated that their congregations have a combined potential of 28,551 missionaries. That represents a fraction of the limitless opportunities God is giving us to join Him on mission. In September, we celebrated the service of our emeritus personnel when about 950 former personnel — representing a staggering combined service of 25,297 years — gathered at Ridgecrest.

Our emphasis on the 2017 Week of Prayer for International Missions highlighted examples of your Southern Baptist missionaries who serve through the IMB in some of the most challenging and difficult-to-reach places in the world. These missionaries, who represent your churches and are sent by you, have shared how God is at work despite hardship and struggles. Southern Baptist missionaries are evangelizing the lost, discipling believers, planting healthy churches, and training leaders — and the Lord is being glorified!

All of this is only possible through the grace of God and through the faithful and continued partnership of Southern Baptist churches. I am pleased to report to you the ways you are giving, supporting, sending and going. As you read this report, I invite you to give, support, send, and go all the more in the days ahead until every tribe, tongue, people, and nation has been reached with the good news of Jesus Christ.

NORTH AMERICAN MISSION BOARD (NAMB)

At the North American Mission Board, we want to help every church and every believer be on mission so they can share the hope of Christ in their communities, throughout North America and around the world. Before reflecting on this past year, I want to express our deep gratitude for the pastors who lead their churches to sacrificially give to the Cooperative Program, the Annie Armstrong Easter Offering® and to the Lottie Moon Christmas Offering®. We are committed to being the very best stewards possible with these dollars. In 2017, Southern Baptists gave an all-time record high to the Annie Armstrong Easter Offering-\$59.6 million.

We are grateful for all God did in 2017 through Southern Baptists and the North American Mission Board. Here are a few highlights:

We are able to resource and support more than 5,200 missionaries.

Southern Baptists started 732 new churches in 2016, the most recent year for which data is available. In addition, there were 232 new church affiliations with the SBC.

Existing church plants are reporting some exciting trends. Churches planted in 2011 had a 77 percent survival rate after year five. Church plants baptized one person for every 10 attendees, compared to one for every 17.4 attendees in established churches. In many "new work" state conventions, located outside the south, churches planted since 2010 account for a high percentage of total Southern Baptist baptisms reported in the state. The Maryland-Delaware, New York and the Northwest state conventions all reported that more than 25 percent of their baptisms came from churches started since 2010. In the Baptist Convention of New England, 42 percent of baptisms came from churches planted since 2010. In Canada it was even higher--62 percent.

This year we introduced the Gospel Conversation (GC) Challenge to encourage pastors to mobilize their churches for evangelism. We hosted three Engage 24 Workshops for pastors, designed to help them kickstart evangelism efforts in their churches.

Along with our partners at the International Mission Board, we hosted more than 13,000 attendees at our three Send Conference events in 2017.

This past year we sent more than \$28 million to state convention partners. This is money that went to fund missionaries and to support evangelistic church planting, evangelism and church revitalization efforts.

The task of reaching North America for Jesus is enormous. But God has given us remarkable resources. We need the help of every Southern Baptist church. Your prayers, giving and involvement are making a difference. Thank you for everything you are doing to help push back lostness in North America.

Mississippi River Ministry (MRM) is one of three arms of the Compassion Ministry outreach of the Tennessee Baptist Mission Board. During this past year, GOTM funds were channeled into seven different West Tennessee associations to assist churches with projects and ministries designed to impact lostness by touching poverty. In addition, over 200 plastic mats for the homeless were made and distributed to ministries throughout West Tennessee. I personally conducted eight (8) training events for over 100 participants.

Tennessee has formally agreed to join with other state conventions in collecting Christmas Backpacks. The Christmas Backpack program has been around since 2000. It has largely been an effort of other state conventions. Tennessee has been mostly on the receiving end. Last year, Tennessee children received 14,630 Christmas Backpacks. Though not asked to give backpacks, Tennesseans gave 334. MRM and Compassion Ministry is leading the movement to see Tennessee join with our other state conventions to give Christmas Backpacks to Tennessee's impoverish children. Many have accepted the challenge to give, but the need is great. For more information, please go to http://www.tnbaptist.org/backpacks.

Today, more churches are needed to reach the underserved affected by poverty in their community. Mississippi River Ministry can assist in four ways:

1. MINISTRY PROJECT FUNDING

MRM channels *Golden Offering for Tennessee Missions* funds through churches and associations for specific ministry projects impacting poverty.

2. MATERIAL RESOURCE CHANNELING

MRM channels donations of material resources into ministry sites and churches to be used in Compassion Ministry.

3. COMPASSION MINISTRY COACHING & TRAINING

MRM provides church consultations and multiple training events and classes that help churches engage in ministry to the impoverished. This year, 15 training events were conducted.

4. VOLUNTEER MOBILIZATION

MRM facilitates placing volunteers from Churches to ministry sites in West TN.
