Afternoon Session

- 1. Call to Order the meeting was called to order at 3:30 PM by Billy Criswell, moderator, and pastor of Bethel-Y.

EXECUTIVE BOARD REPORT

The Executive Board of the Gibson Baptist Association is composed of one elected representative from each church and the pastor of the church. The Constitution and Bylaws require the board to meet quarterly. The Executive Board has as its purpose to conduct the business of the association between annual meetings.

January Executive Board Meeting highlights:

Twenty-eight executive board members representing sixteen churches were present at the January meeting. Bro. Joel Pigg, assistant treasurer, gave the financial report and informed the board that the association was \$2,600 short of the budget. Randy Pool, TBC representative and Harvest Field 2 representative, shared about what the Tennessee Baptist Mission Board is doing across the state, and emphasized the Christmas backpacks, and shared about Compassion Ministries. Tiffany Dawson, director of development for BirthChoice, informed the board about fundraisers for Birth Choice. She shared about the many services that BirthChoice offers such as counseling for those considering abortion, parenting classes, abstinence education, and Bible study for post abortion. During its ministry, they had helped around 18,000 women. Bro. Roger Stacy, DOM, shared how the association is a family and the state and national levels are affiliates. Gibson Baptist Association has been asked to host the Strawberry Festival Prayer Breakfast in May. Sheilah Spangler, WMU Director, reminded the board of the upcoming Jerry Legg Volunteer Mission Banquet on February 7, 2018 at Fruitland.

April Executive Board Meeting highlights:

There were 15 Executive board members at the April meeting. Jim Acree, treasurer, gave the financial report. He reminded the board that we are \$6,000 behind where we need to be. Bro. Roger Stacy, DOM, gave his report and emphasized the upcoming mission trip to Brazil. He also shared about the Union students that will be preaching in churches the first Sunday in May. Rhonda Poore gave the WMU Report in the absence of Sheilah Spangler. She shared about the National Day of Prayer event. Bob Moore, Men's Ministry Leader, gave an update on the GBA church softball league and some changes to be implemented. Bro. Andy King, Send Team leader, gave the Send Team report and encouraged the churches to give to the Wingo Fund. He also shared about the growth at Fruitland for the last 2 years from 15-20 older people to 21 kids on a previous Wednesday night and 50 in church on Sunday morning. The board authorized Bro. Roger to work with the appropriate team on a graphic design of a yard sign that would promote and support Pro Life.

July Executive Board Meeting highlights:

The Executive Board met at First Baptist Church Dyer. Bro. Lane Self was recognized as the new pastor of Dyer First Baptist Church. Jim Acree, treasurer, reported that we were short about \$6,400 in budget receipts. Bro. Roger Stacy, DOM, reminded the pastors about upcoming events in particular the Deacons' Meetin' at Whitehall on September, 5, 2019 and the God & Country Rally at the Gibson County Courthouse on September 11, 2019. A recommendation was approved to elect Bro. Bryan Morris to serve on the Personnel Committee and Bro. Joel Pigg to serve on the Budget Committee. Dr. Randy Davis, Executive Director of the Tennessee Baptist Convention, was the special guest speaker for the board meeting. He gave some updates on ministries around the state and convention activities. He stressed that our work is in concentric circles: the church, the association and the state. He also expressed his concern for the health of pastors of our local churches. Dr. Davis shared about his burden for the unborn and the need to stand against abortion. He spoke about the Tennessee Baptist Mission Board's initiative "I Stand for Life". He will be speaking to the state legislature on August 12, 2019, and will present signed petitions to the Tennessee state legislature. Dr. David reminded pastors to sign the petition and have church members to sign also.

(ASSOCIATIONAL MISSIONARY)

As I submit this report to you this year, it is with a sense of gratitude for allowing me to serve as your associational missionary (DOM). I am more than happy to tell my colleagues across the state that Gibson Baptist Association of Churches is the best Association in the state. I also come before you in this report to express a deep gratitude to Dianne Klutts who has served this Association as Ministry Specialist for almost twenty four years. Dianne announced her retirement this fall. This will be a tremendous loss to this Association and to me as well. We wish her the very best as she and her husband, Bro. Danny, continue serving the Lord.

I attended the National Renovate Conference (Church Revitalization Conference) in Orlando, Florida, the week of November 6-8, 2018. Bro. Shawn Allred joined me for the week of training under the direction of Dr. Tom Cheyney.

I led mission teams to serve in Brazil this past year as a part of our partnership with the International Mission Board. The week of November 23-December 1, 2018, the team served in Rio de Janeiro. As a part of our ministry plan through the Strengthen Team, funds were budgeted to pay the registration fees for these couples.

I led a group of thirty-three (33) people to the Holy Land the week of February 18-27. The group was composed of members of GBA churches and in our association. A few people joined our group from another association and other churches outside of the GBA.

We celebrated our fourth annual "Jerry Legg Volunteer Missions Banquet" on February 7, at the Fruitland Baptist Church. Bro. Andy King received the Missions Volunteer of the Year award for his outstanding service in missions.

On April 2, we offered a Vacation Bible School Clinic at Salem Baptist Church. I would like to see every church in our association have a VBS this next year.

White Hall Baptist Church hosted our Bible Drills once again. Rhonda Poore and the Strengthen Team planned and served to make the Bible Drills a success.

Twenty-one churches hosted Union University student preachers the weekend of May 5. Churches gave a love offering totaling \$3, 477.23. Our association hosted more student preachers than any other association to date.

The Strawberry Festival Committee asked the GBA to host the West Tennessee Strawberry Festival Prayer Breakfast on May 5. Bro. Bert Harper with American Family Radio was the guest speaker. There were approximately 170 in attendance.

On September 11, the GBA held a "God & Country Rally" on the courthouse steps in Trenton. This was to remember 9/11 and honor first responders, law enforcement, chaplains, and other emergency personnel. Michael Imhof, a former US Navy Commander and Navy Seal, was the evangelist speaker.

2019-2020 GUIDELINES FOR WINGO MISSION FUNDS

In order to receive Wingo Funds for any mission trip or project, all volunteers must undergo a background check with the GBA. This requirement is in compliance with our mission sending agencies of the Southern Baptist Convention, and is for the legal prudence of the GBA. No funds will be dispersed for any trip or project until the background screening requirements are completed and payment has been received.

BACKGROUND SCREENING REQUIREMENTS

1) Volunteers must submit three references using the reference forms provided by the GBA. The references must be from individuals who are not family members of the volunteers and must be at least 21 years of age.

One of the three references must be from the pastor of the church where the volunteer is a member. In cases where the church is without a pastor, a staff member or chairman of deacons may serve as a reference.

- 2) Volunteers must complete a personal interview questionnaire form provided by the GBA.
- 3) Volunteers under the age of 18 are only required to submit reference forms and the personal interview questionnaire.
- 4) Volunteers who are older than 18 must have a background check through the company used by the GBA. A consent form will be provided for the volunteer to grant permission for the background check.
- 5) The volunteer will be responsible for paying the fee for the background check.
- 6) Volunteers are required to watch a child protection video provided by the GBA.
- 7) Volunteers are required to undergo background screening every four years with the GBA.
- (8) Churches participating in a mission trip other than a GBA led trip, shall conduct the background screening as outlined above. All background screening forms shall be maintained on file with the church. GBA will make available online background checks for churches. When a church has completed the background screening, an authorized representative of the church must sign a declaration statement provided by GBA, verifying that the background screening has been completed for every mission volunteer receiving Wingo Funds. Background screenings are valid for four years. In cases where a church receives a Church Scholarship (Multiple Scholarship), the same procedures must be followed along with a signed declaration statement to the GBA. Wingo funds will not be granted until such procedures are completed.

INTERNATIONAL MISSIONS PROJECTS

GBA Volunteers and churches participating in an official project of the Gibson Baptist Association, the Tennessee Baptist Convention, or the International Mission Board are eligible for travel assistance from the Wingo Fund account. Scholarships from this account primarily seek to encourage and help GBA volunteers (ages 15 and older or a student who has completed 9th grade) to participate in a 'first time' mission trip. The following guidelines apply for use of Wingo Funds:

- 1) Funds are designed to assist volunteers who participate in an official IMB trip/project. First time international mission volunteers are eligible for a scholarship of \$400.

 2) Volunteers who have previously participated in an official IMB project/trip are eligible for a \$300 scholarship once per associational calendar year, if it is an IMB project/trip.

 3) Churches may request a multiple scholarship for volunteer team members of the same church once in the
- calendar year.
- endar year.

 A multiple scholarship is designated when a group of volunteers from a single church are participating in the same project/trip.

 A multiple scholarship amount will be limited to \$2,000 for the project/trip.

 Only one multiple scholarship can be granted to a single church in the calendar year.

 Additional scholarships may be awarded to other individuals of a church that has received a multiple scholarship (under existing guideline) up to \$1,000 over and above the multiple scholarship.

 Scholarship requests that exceed the \$3,000 limit for a church may be considered by the Send Team. It is encouraged that first time volunteers be distributed their full \$400 scholarship from this amount, if possible.
- 4) Volunteers (first time or otherwise) not participating in a multiple scholarship project/trip with their church are still eligible for an individual scholarship once during the association calendar year.
 5) Volunteers requesting funds must complete an application which is available at the GBA office or by e-
- 6) Wingo funds will be disbursed as early as possible with adequate notice prior to the date of the project/trip. Special considerations may be submitted to GBA.
 7) Any special requests/needs for funds not addressed in these guidelines may be addressed to the necessary
- channel of the Send Team.

 8) In order to help and encourage pastors who have never participated in an IMB international mission trip while serving as a GBA pastor, a \$ 1,000 pastor's scholarship will be available for five pastors each year (first come, first serve basis). To qualify, this must be the pastor's first IMB international mission trip as a GBA pastor. The pastor will still be eligible to receive Wingo funds for first-time mission volunteers along with this scholarship. It must be an official trip of the International Mission Board and be in compliance with all guidelines for Wingo mission funds.

DISASTER RELIEF PROJECTS

1) International disaster relief projects will qualify for travel assistance for GBA volunteers as listed above. However, for International Disaster Relief Projects, the minimum amount from this fund shall be \$500 for any volunteer from GBA, regardless of the number of trips/projects the volunteer may have participated in.

2) Matching funds from the local church is encouraged.

- 3) The maximum total contribution to volunteers from a single church for any specific project/trip travel assistance is \$2,000.
- 4) USA disaster relief projects qualify for gasoline reimbursement for volunteers from GBA going to a disaster point as called upon by the GBA or TBC.
- 5) An allocation of up to \$1,000 may be given to any area where a disaster has occurred. The gift and amount is to be determined by the Send Team of the association.

NORTH AMERICAN MISSIONS PROJECTS

GBA Volunteers and churches participating in an official project of the Gibson Baptist Association, the Tennessee Baptist Convention, or the North American Mission Board are eligible for travel assistance from the Wingo Fund account. Scholarships from this account primarily seek to encourage and help GBA volunteers (ages 13 and older or a student who has completed 7th grade) to participate in a 'first time' mission trip. The following guidelines apply for use of Wingo Funds:

- 1) Funds are designed to assist volunteers who participate in an official GBA, TBC, or NAMB trip/project more than 200 miles round trip from the Gibson Baptist Association Office out of state. First Time North American mission volunteers are eligible for a scholarship of \$150.
- 2) Volunteers who have previously participated in an official North American Mission project/trip are eligible for a \$100 scholarship once per associational calendar year, if it is a North American Mission project/trip.

3) Churches may request a multiple scholarship for volunteer team members of the same church once in the

calendar year.

A multiple scholarship is designated when a group of volunteers from a single church are participating in the same project/trip.

• A multiple scholarship amount will be limited to \$1,000 for the project/trip.

• Only one multiple scholarship can be granted to a single church in the calendar year.

- Additional scholarships may be awarded to other individuals of a church that has received a multiple scholarship (under existing guideline) up to \$375 over and above the multiple scholarship.
- Scholarship requests that exceed the \$1,375 limit for a church may be considered by the Send Team.
- It is encouraged that first time volunteers be distributed their full \$150 scholarship from this amount, if possible.
- 4) Volunteers (first time or otherwise) not participating in a multiple scholarship project/trip with their church are still eligible for an individual scholarship once during the association calendar year.
- 5) Volunteers requesting funds must complete an application which is available at the GBA office or by email.
- 6) Wingo funds will be disbursed as early as possible with adequate notice prior to the date of the project/trip. Special considerations may be submitted to GBA.

7) Any special requests/needs for funds not addressed in these guidelines may be addressed to the necessary channel of the Send Team.

WINGO OFFERING

1) The Wingo Offering is named in honor of Rev. Charles Wingo, the first Director of Missions of the Gibson Baptist Association.

2) Wingo Funds exist to encourage volunteers and church participation.

3) The Send Team will annually recommend to the Annual Meeting of the GBA the Wingo offering goal for the year.

4) Gifts from churches or individuals for the Wingo offering are welcomed during the budget year.

- 5) The recommended date for receiving the Wingo Offering in the churches will be the last Sunday of July of each year.
- 6) The Send Team shall recommend to the Annual Meeting of the GBA the allocation of Wingo funds (International, North American, Disaster Relief).

THE SEND TEAM RECOMMENDS

1). 2019-2020 Wingo Fund Goal of \$ 23,000.

SEND TEAM REPORTS

WINGO FUND REPORT

In 2018 - 2019 GBA churches and individuals gave \$ 21,744.39 towards the 2018-19 Wingo offering goal of \$22,500. This assists a variety of mission projects during the year. This amount was \$ 755.61 short of the goal. Last year our churches gave \$ 18,133.12 toward the 2017-18 goal. At the 2017-18 Annual Meeting the Wingo Offering total was \$ 1,354.00 which brought the Wingo Offering grand total to \$ 19,467.12. As an association, we celebrate the sacrifice that individuals and churches have made to help us as we strive for the goal.

In 2018-19 Wingo Funds were used to help forty (40) individuals from twelve (12) GBA churches receive scholarship assistance through the Wingo Funds to help them bear the cost of their mission trip to three (3) different countries. Last year sixty (60) individuals from fourteen (14) churches used the Wingo Funds to help go to three (3) countries.

The total GBA /IMB scholarships distributed this past year was \$13,500. The following is a list of those receiving funds and the country in which they served.

BRAZIL MISSION REPORT

The Gibson Baptist Association continues working with the International Mission Board to reach Brazilians with the gospel, plant churches, and develop disciples of Jesus Christ. Another aspect of what we do is to strengthen mission congregations that are struggling to grow and reach the point of becoming an organized New Testament Church. Brazil is also putting a heavy emphasis on church revitalization and our association has served alongside churches in Brazil to help in this area.

The week of November 3—December 01, 2018, a team of volunteers worked in Rio de Janeiro. The team did door-to-door evangelism with a heavy emphasis on discipleship for the new converts. There were 123 professions of faith in Christ for the week. One of the highlights was working in a favela (slum area) called "Mangueira" (Water hose) where 150 children live. Most parents are involved in drugs and prostitution. The Home Mission Board of Brazil has a couple working to rescue these kids from the streets, feed them, cloth them, and help them get their birth certificates. It costs about \$50 a month to help one child. The mission team shared the gospel with their parents and some made professions of faith.

The trip in April (22-30) was to conduct a crusade in Rio de Janeiro. The team of pastors worked with Pastor Douglas Xavier da Silva and preached in churches in the city for the week. There were a total of 334 professions of faith for the week. Again, the team focused on discipleship Bible studies to help new converts grow in their faith. The team engaged many armed young men selling drugs and protected by a drug lord. Some of the young men were saved, but most were afraid to betray the drug lord and risk death. These young men are lucky to make it to age 25, and if one of them reaches 30, he is called "grandpa." Our team saw a spiritist come to faith in Christ.

The week of June 17-25, a team worked in another area of Rio with two churches. Both were struggling churches with one of them having closed its doors, but reopened. Part of our team was unable to made connections due to the weather and did not make the trip. This left our team with only five members instead of thirteen for the week. God blessed and sixty-four professions of faith were recorded for the week. We continue to hear how God is blessing these two churches and bringing new life because of the work of our team. The discipleship Bible studies continue on that our team started with new believers and there have been baptisms of new converts.

Pastor Douglas in Rio de Janeiro is putting together another crusade (simultaneous revivals) in Rio the first week in February 2020. Our goal is to take twelve (12) preachers to preach in twelve churches, along with a lay person for each church.

Thanks to the Wingo funds we are able to help a pastor who is new to our association or a pastor who has never been on an international trip under the umbrella of the Association.

Pray about joining us as we continue to reach Brazilians with the gospel in 2019-2020.

OHIO MISSION REPORT

The West Central Baptist Association in Ohio is our sister association and we continue our relationship with them. This is a vast area to be reached with only a handful of churches in the association. The association covers ten (10) counties with over 550,000 residents. There are only 14 Southern Baptist Churches in these ten counties that compose the association.

The GBA has partnered with the West Central Association to help plant a church in the cities of Minster and New Bremen. We have had a team to work in the area previously and we need more teams to help.

One of the tools we are currently using is praying for the lost and for an openness to the gospel so that we can find a person of peace or people of peace. The goal is to find this person of peace to begin a home Bible study.

The Hillcrest Baptist Church in the West Central Association is the sponsoring church of this new work.

Pray about taking a team to this area of Ohio this year.

GIBSON BAPTIST ASSOCIATION WMU

WMU, at the associational level and in every church, has been very active this year.

Prayer meetings - (organized and conducted by the GBA WMU Prayer Support Coordinator) Baptist Women's World Day of Prayer was cancelled due to severe weather.

National Day of Prayer at the Humboldt Medical Center Conference Center included a catered lunch and was attended by 70 residents of the county. "Cowboy" Dan Harrell spoke.

Annual Jerry Legg Volunteer Missions Banquet – (a joint event with the GBA Send team)

Over 70 people attended at Fruitland Baptist Church. William Burton, TBC, spoke. Bro. Andy King, pastor of Fruitland Baptist, was recognized as 'Volunteer Missionary of the Year'.

Quarterly meetings – (organized by GBA WMU Area Directors)

Approximately 130 women from churches across the association attended the associational WMU meetings this year. Speakers were:

Brian Gallimore, Hope Outreach Ministry, also spoke about the Dresden women's shelter. Over 100 purses were filled with necessities for the women from donations brought to the meeting. Vickie

Anderson, TN WMU Executive Director, closed the program.

Girls Living Out the Word (G.L.O.W.) Camp – (organized by the GBA WMU GA consultant)

The annual camp for 1st through 6th grade girls took place at Reelfoot Retreat Center Aug 23-24. Sixty five girls from 10 churches attended the event organized by Pamela Basham.

State and National Missions Offerings - (organized at each church)

WMU women from across the association promoted the Golden State Offering for Tennessee Missions, Lottie Moon Christmas and Annie Armstrong Easter offerings.

Local Church Support Activities – (organized at each church)

Untold hours were devoted to children's missions education, charitable projects, missions support and mission trips throughout the year at each church in the Association.

SEEK TEAM REPORTS

Our GBA SEEK Team's overall strategic goal is to assist the churches in the GBA to meet TBC'S Objective 1: "Seeing at least 50,000 Tennesseans annually saved, baptized, and set on the road to discipleship by 2024", approved by Tennessee Baptists at the 2014 Annual Summit Meeting. For the GBA this will mean reaching at least (385) Tennesseans in 2019/2020 annually, for churches of the GBA this will mean reaching at least (7) individuals per church annually. Our prayer is that we will see this goal accomplished collectively!!!

Following are the goals that The SEEK Team set for GBA in 2019/2020:

- 1. To assist churches in the GBA in fulfilling the Great Commission. We will have three crusade events to be held in three different regions of our association with locations to be determined. The crusade events will take place during the month of September 2020. We will ask our (55) churches to participate. The anticipated expenses for the crusade events will be \$2,000 per event. These funds will be used to provide for the expenses of setup, guest preachers, musicians, and groups, promotional flyers, advertisements, fees for clean up after the events, and other expenses. We will ask churches in their regions to contribute to the cost of the crusade events.
- 2. To assist churches in the GBA fulfill the Great Commission, we will continue to work with Bro. William Burton, Hispanic Strategist of the TBC to provide a strategy to start a new Hispanic work in our Gibson Baptist Association. We suggest that The Church at Sugar Creek, the sponsoring church, provide a written ministry plan as part of that engagement with our Gibson Baptist Association. The SEEK Team will use Golden Offering funds to support the Hispanic ministry (designated funds) which will be available by the end of September 2019.

We continue to pray together for churches in the GBA to be engaged in "Conversations of the Gospel of JESUS CHRIST" in Personal Evangelism. Every believer is called to share the Gospel of JESUS CHRIST and we continue to pray that lost people will be birthed into GOD'S KINGDOM!!

EVANGELISM

Thirty-three (33) GBA churches reported baptizing one hundred sixty-three (163) people this year. Last year thirty-four (34) GBA churches reported baptizing 225 people. We baptized sixty-two (62) less people this year.

VACATION BIBLE SCHOOL

We would like to encourage all of our churches to have a Vacation bible School this next year. If we do not reach children and youth with the gospel through VBS we will perhaps never reach them as adults. VBS is the most effective tool the church has to reach the lost. Here are some helpful facts about Vacation Bible School based upon research from LifeWay.

- 25% of Baptism reported by the Southern Baptist Convention come from VBS.
- Every 1 person trained in VBS results in 1.1 salvation decisions.
- VBS increases the number of prospects discovered from your community.
- 10% of people enrolled in VBS are unchurched.

Our Association Vacation Bible School team attended the training led by the Tennessee Baptist Convention at West Jackson Baptist Church.

This year our Association held our training at the Salem Baptist Church in Trenton. The clinic was held on Tuesday evening, April 2, 2019. There were approximately 50 to 60 present for the training with representation from several of our GBA churches. The theme this past year was "In the Wild: Amazing Encounters With Jesus." The 2020 theme will be "Concrete and Cranes - Building on the love of Jesus and showing kids the foundation that lasts!." This year thirty-two (32) GBA churches held a Vacation Bible School. There was an enrollment of 2,330 on the churches campuses.

STRENGTHEN TEAM REPORTS

I am pleased to report that we have experienced a very good year in the Strengthen Team of the Gibson Baptist Association. These are a few of the highlights:

Christian Women's Job Corps. As a result of being in the Gibson County Correctional facility this year, 13 ladies have openly accepted Christ as their Savior, and another 15 rededicated their lives. Through many generous donations, equipment and supplies were purchased in order to further the kingdom growth by the sharing of His word.

God really has provided this year by arranging the purchase of a transitional home for ladies coming out of incarceration which will provide mentoring for the ladies and programs for advancing their independence.

Men's Ministry Report. This year the focus of the Men's Ministry has been on partnering with our sister churches of the association. The Strengthen Team is responsible for oversight and assistance in the men's ministry.

Our Youth team was once again active this year. We held a youth rally at the Strawberry Festival and another at the Gibson County fair. These evangelism events saw many come to Jesus in repentance and faith.

The Deacons' Meetin' was a huge success. It is held annually at White Hall Baptist. There were approximately 250 in attendance and they heard a powerful sermon from Dr. William Oakley. Kelly Sorrell and the Antioch Baptist Church did a great job in leading in worship.

Our GBA Pastor's Conference is a weekly opportunity for our pastors to come together and fellowship, learn, discuss, vent and praise our Savior for His goodness. This is an event that if it were to be discontinued, the entire association would feel the repercussions. We pastors are so blessed to have a Associational Missionary that supports this effort.

Our Senior Adult events were once again well constructed and well attended. They were both "packed out" with the "well seasoned" members of GBA. Everyone had a great time of food, fun and fellowship and we are all anxiously awaiting the next event!

One of the ministries most actively overseen by the Strengthen team is softball. This year we appointed a new Commissioner, Mr. Bob Moore and a new co-Commissioner, Mr. Eric Patton. We revamped the rules to

ensure an "even playing field" and that everyone involved knew and understood the rules. It was a great season with 8 men's teams and 4 co-ed teams.

The Bertie Thompson Ministry scholarship went to a deserving young man by the name of Thomas Littleton. Thomas is attending seminary in order to be prepared to pursue God's call for his life. Congratulations Thomas!

The GBA Strengthen team is considering the possibility of offering courses through our own Bible Institute in order to help our pastors to answer the call that God has given them in His ministry. Pray for us as we move forward with continuing education. It has been a busy year and with God's help and blessing, 2020 will be even more fruitful!!

CHRISTIAN WOMEN'S JOB CORP

In reflection, GOD continues to do a mighty work as we serve the community of Trenton and Gibson County. We continue to pray and serve and trust God as HE leads us. We dare not take credit for what HE alone can do.

As a result of being in the Gibson County Correctional facility this year, 13 ladies have openly accepted Christ as their Savior, and another 15 rededicated their lives. Our first class this year resulted in 5 ladies completing the 16 week "Powered for Life" class in May. Two of those graduates currently volunteer in the store and are in line for our dental program through Agape Smile and Elite Dental. Our second class started on August 13th with 17 enrolled. Classes also started once again in our classroom at Twice Blessed on August 14th.

In addition to the abundance of blessings through all of your donations both in-kind and monetary and the prayers and support of wonderful volunteers, we received \$500 from the GOTM for the purchase of a new laptop. We also received \$350 from Mississippi River Ministry for shelving in our sorting room at Twice Blessed. We reflect with pride regarding the 20 plus volunteers who attended annual training for Gibson County Correctional Facility. We are grateful that we continue to be able to provide food and clothing to the community, and we consider it our greatest privilege to minister and witness to those who come to our thrift store.

The purchase of a transitional home for ladies coming out of incarceration very quickly became a reality this year. The work of bringing all of this together will require even greater support from our churches and community. We were able to make a sizable down payment on the house, but will have salaries and a mortgage payment along with liability and property insurance, utility bills and general maintenance. We anticipate having ladies in the home as early as November. Please join us in praying for a Facility Manager and volunteers for transporting and mentoring the ladies and programs for advancing their independence.

Our 7th Annual "Night of Hope" this year will be at Salem Baptist Church at 199 Neal Kinsy Rd. in Trenton on November 5th. We hope that you will be able to join us for this important fundraising event in the ministry of CWJC.

BIRTH CHOICE

I wanted to do something a little different with this annual report, yes we always have needs and you all are so gracious to meet those needs, but I wanted to share what happens when those needs are met with some stories for you all.

1. Anna (name changed to protect privacy) came to us; she was very upset. She had recently broken up with her longtime boyfriend who was the father of her other child as well. She was also upset knowing that she was even considering aborting her child. Anna knew abortion was wrong, but she feared being a single mom of two.

But when Anna had her ultrasound, she saw she had a big, 20 week baby that "melted my heart." She chose life and said "I'm so relieved the baby is so big that the choice was taken out of my hands." Since she was so far along Anna asked our volunteer nurse, "Why didn't I know I was pregnant?" The nurse replied, "Because God revealed it to you in His time, so the decision could be out of your hands." The nurse prayed with her, and afterward Anna told her she planned to use the ultrasound picture to tell her mom she is pregnant! Before she left, Anna turned to the nurse and said, "all of my fear is gone!"

2. When Tammy (not her real name) first came to us she already had more than one child and was still young. Sexually abused as a child, she struggled with drug addiction and her boyfriend was a known drug dealer. All these issues helped her make up her mind to abort her baby. But after meeting with our client advocate and seeing her baby on ultrasound she decided to give life to her child. Fast forward a few years, Tammy came back to see us and was pregnant yet again. After spending time in prison and being drug free for many months she had turned her life around and seemed to have given her heart to Christ. She was scared of many things. She was still trying to navigate changing the many obstacles she faced based on a lifetime of bad choices. Again, she was abortion-minded, but she didn't really want to abort this child. However, she was concerned about how she would care for the baby

God addressed that concern when she joined our E.S.T.H.E.R. parenting program and learned about caring for children, making better life choices, and much more! She also earned "mommy money" to spend on several needed items in our baby boutique. The baby she was pregnant with is now several years old!

- 3. Some years ago Debbie (not her real name) called and told us that she had to have an abortion. Our receptionist tried very hard to get the 21-year-old woman to come in, but Debbie finally blurted out, "but you don't understand. I'm an exotic dancer and there is no way I can have a baby." She did come in, however, and met with a wonderful young client advocate who committed to listen to Debbie's story. When Debbie finished talking, the client advocate asked if she could read something to her from Scripture that may help. Agitated, she replied, "I didn't come here for any of your religious stuff, I just want to know if I'm pregnant." The client advocate said that she understood, but before Debbie left the young volunteer asked one thing of Debbie: "May I give you a hug before you go?" "Yes, get it over with," she replied. As the client advocate hugged her, Debbie's heart melted and she broke down in tears. Debbie confessed to the young volunteer, "You are the only person that has ever touched me without requiring something in return." Debbie had been literally thrown onto the streets of Dallas TX at age 14 to fend for herself. Debbie not only decided to give life to her child but to give her heart to Christ as well. She promptly left her job as a stripper and went to the police to expose all the illegal activity that was going on in Jackson's once infamous strip club industry. Debbie is a major reason that Jackson has no more strip clubs because the police and courts CLOSED THEM ALL.
- 4. One day, a client and her boyfriend were visiting Jackson on vacation. Knowing she was pregnant, they Googled "abortion" and Birth Choice popped up. They didn't call for an appointment; they just walked in off the street.

The couple was determined to have an abortion when they came in, but after speaking with our client advocate and receiving an ultrasound she changed her mind and chose life. They were also very interested

to hear about God, His Son, and the price Christ paid for mankind's sin. Neither of them had ever heard the gospel before and both decided to give their hearts to Christ!

Countless lives are being saved and reached for Christ not only at our offices but through our outreach programs of 'Real Talk' that we take into the schools, the 'Stone Covenant' that we take into our church youth groups, and our post-abortion outreach currently called M.E.R.C.Y; but will take on a new name for the new year. Whenever you give, volunteer and pray you become a part of what God is doing in our community.

EXCITING NEWS: The mobile medical unit is scheduled to be here in January! We are so excited to be able to reach more that are seeking abortion as a solution and to reach more with the Gospel!

MEN'S MINISTRY REPORT

This year the focus of the Men's Ministry has been on partnering with our sister churches of the association. We have supported financially some of the men's events our churches have provided this year.

Many of our churches provide valuable and effective ministries to men such as car shows, wild gam suppers, etc. The Strengthen Team is responsible for oversight and assistance in the men's ministry.

BLOCK PARTY WAGON

We are grateful for the Block Party Wagon (BPW) ministry. Fewer churches have used the BPW this year to reach their communities for Christ. When the state of Tennessee passed a law governing the use of jumpers (bouncy houses), many associations ceased to have block party wagons. This has also affected the use of our Block Party Wagon. We are currently working with the state on certification so that we can once again use the bouncy house.

The Block Party Wagon (BPW) is available for any GBA Church on a first-come-first-serve basis. The restriction is that it must be used in some form of evangelism outreach.

YOUTH TEAM REPORT

This year the Youth Team held two events. During the West Tennessee Strawberry Festival in May, there was a youth rally that was held at the Church at Sugar Creek in Humboldt. The group TruStory, a praise and worship band from Union City led the youth in worship. Bro. Travis Ellis, youth pastor at FBC Kenton, was the speaker for the evening.

The Gibson County Fair once again asked the Gibson Baptist Association, Bro. Roger Stacy, DOM, to organize a youth night event at the fair. The GBA Youth Leadership Team planned and coordinated a youth night at the fair on August 28, 2019. Worship was led by 40Save1, and the special speaker for the evening was T.J. Gilliam from Alabama. T.J. is a poplar youth speaker and is well known. There was approximately 350-400 in attendance with several professions of faith.

DEACON'S REPORT

The Deacons' Meetin' was born in the heart of the late Kenneth Brown, a deacon at White Hall Baptist Church. Mr. Brown had a burden to see the men of the church step up and lead the work of the church for Christ. The first meeting was held in 2007 at White Hall, and we continue seeing this event grow in strength and number. This year we had a record number to register for the meal and attend the meeting. There were 176 registered for the meal and the attendance for the worship service was about two hundred fifty (250).

We met again this year on September 5. This annual event falls under the guidance of the Strengthen Team and its ministry. Bro. Steve Skelton has served many years in helping with the Deacons' Meetin' and once again led the service.

A meal was served at 5:30 pm followed by the program at 6:25 pm. Northside Market in Milan catered the meal for the evening.

CONTINUING EDUCATION REPORT

"Study to shew thyself approved unto God, a workman that needeth not to be ashamed, rightly dividing the word of truth." (2 Timothy 2:15)

The Tennessee Baptist Convention is considering developing a Bible Institute program to help train and develop lay leaders and pastors. Some associations are also offering courses through their own Bible Institutes. The GBA Strengthen team will be considering this possibility of offering courses through a Bible Institute as we move forward with continuing education.

Another option for continuing education is Seminary Extension. These courses are available online for anyone desiring to receive credit for study or to study without seeking any degree. Our six Southern Baptist Seminaries provide this course of study.

SUNDAY SCHOOL REPORT

For the last several years, the Annual Church Profiles show that Sunday School attendance and enrollment have continued to drop. The annual church profiles for 2018/19 shows that Sunday School enrollment decreased again. Our churches reported a Sunday School enrollment of 5,567 which is a decrease of 606 people from last year's enrollment of 6,173. Our Sunday School average attendance also decreased by 299 people with the 2017/18 average attendance at 3,912 and the 2018/19 average attendance at 3,613.

GBA has 30 churches reporting between 1-50 in average Sunday School attendance, 9 churches reporting from 50 -100 in attendance and 16 churches that report having over 100 in average Sunday School attendance.

DISCIPLESHIP TRAINING REPORT

Discipleship Training has decreased this year from last year. This year twenty-two (22) of our churches reported a total enrollment of 1,081 in Discipleship Training. Last year seventeen (17) churches reported an enrollment of 1,090. The enrollment decreased by 9 members.

TENNESSEE BAPTIST CHILDREN'S HOMES

Over 8,000 children in Tennessee need a safe place to call home. The heroes who support TBCH through prayer, service and gifts, enable us to welcome as many of these children as we can with the love of Christ.

Join us in praising the Lord for the 13 children in our care who have been born again during the last nine months while on our campuses or in one of our foster homes! Not every child in our care accepts Christ, but all of them hear the Gospel and see it lived out through the faithful service of our staff, our foster families, our volunteers and in the churches that our children attend. By God's grace an eternal impact is being made on these precious lives.

In 2019 we have cared for 104 different children in our on-campus homes through the **Residential Care** program. While many of these children still reside on one of our three campuses, 26 children have been successfully reunited with their families, and seven children have been adopted and placed in a forever family! We continue to assist ten of our residents who are transitioning out of our care into adulthood as they attend college or are learning a trade. Last December, we celebrated with one of our young men as he graduated with his bachelor's degree from East TN State University. And more recently, one of our young men enlisted in the armed services where he desires to serve our country and expand his options for the future.

TBCH's **George Shinn Foster Care** program has served 149 children and has had 40 Christian parents commit to providing a Christian home for children in foster care. There are currently 16 of these children in "Foster to Adopt" situations that we are praying will result in each of them having a permanent family. It has been our goal to serve 100 foster children at any one time by 2020. In June 2019 we were serving that many children – 6 months ahead of schedule!

We plan to have the Kingsport foster home up and running in 2020 and are searching for Christian parents who might have the heart for fostering but who might not have the home. This will expand our ministry presence back into the northeast section of our state which we have been desiring to do for several years. Through the **Family Care** program TBCH sponsored three Empowered to Connect conferences for fostering or adoptive families, as well as professionals who serve children. This partnership with churches and local agencies resulted in 50 people being trained in the principles of Trust Based Relational Intervention. We continue to network with families, churches and other organizations to enable them to be successful in caring for children who come from hard places.

This great work would not be possible without the faithful support of Tennessee Baptists. Nearly 1700 volunteers have served on our campuses! Thank you for supporting the Cooperative Program, participating in the Mother's Day Offering or giving us a slice of your World Missions Offering. All of these directly bless the children in our care.

Tennessee Baptist Adult Homes continues to provide a Christian residential ministry for senior adults and for exceptional adults. This ministry is provided in senior adult living communities and in residential group homes in several locations within our great state. You may recall that we sold the Baptist Health Care Center in Lenoir City in 2016. The sweeping changes in the delivery of nursing home care over the past two decades gave rise to the need to sell the facility. Its antiquated architecture would have required monumental expenditures to make it compatible with the newer codes and standards for Skilled Nursing (SNF).

Related to the sale of BHCC, the TBAH Board of Directors made the tough decision this year to discontinue the development of Williams Ferry Pointe in Lenoir City. This independent senior living community was to be the third and final part of a Continuing Care Retirement Campus (CCRC). Since the other two parts of the CCRC, the nursing home and assisted living wing of Baptist Health Care Center, are no longer functioning, pursuing the development of Williams Ferry Pointe was outside the mission of TBAH.

Baptist Village of Johnson City now continues to provide low-income housing for financially needy seniors. These duplex homes are for retirees who need affordable housing and the rent is based on income. Preference is given to retired ministers and missionaries.

The Deer Lake Retirement Community in the Bellevue community of Nashville is a 135-condominium unit complex for retirees. These modest duplex homes offer home ownership in an affordable retirement community. TBAH provides a manager for the complex and employs a part-time chaplain for the spiritual care of these independent seniors.

The group home ministry for exceptional adults continues to provide a Christian home for up to 55 men and women who need assistance and supervision. These homes, located in Nashville, Lebanon, Knoxville, and Jacksboro are often a forever home for the individuals who move in. Their diminished intellectual abilities would make them too vulnerable to live alone in the community. These homes provide family. Your generous gifts to the annual Father's Day Offering keeps these homes going.

Funded primarily by the Golden Offering for Tennessee Missions, Special Friends Camp ministers in at least three ways; 1) it provides a week of activities for the campers with intellectual and physical disabilities, 2) it allows a week of respite for the families of the campers who provide care day in and day out at home, and 3) it provides two weeks of rewarding, hard work for the young people who staff the camps...not to mention the life-long friendships these young staffers make as Counselors. Special Friends Camp experienced a lower number of attendees this year due to difficulty in finding young people to serve as Counselors. Please direct any high school and college students to specialfriendscamp.org for information on how to apply to be a Counselor for Special Friends Camp.

Tennessee Woman's Missionary Union 2019 Annual Report

In 2018-19, Tennessee WMU focused on encouraging and equipping Tennessee Baptists to know God more, show His love unconditionally, and make disciples who make disciples. This report shares information about some of the state events, ministries, and initiatives that have taken place.

EVENTS

Equipping Missions & Ministry Leaders – In August 2018, 226 new and experienced church leaders from 65 churches attended three regional Equipping Missions & Ministry Leaders events for fellowship, updates, and training. The theme was *Unshakable Pursuit* and leaders heard about avenues to help others know God more, show His love unconditionally, and make disciples who make disciples.

JAM – Last fall 658 children and leaders attended three regional JAMs, a missions event for children in grades 1-6 and leaders. Children learned about racing to make Christ known, met missionaries from around the world, and collected ministry project supplies. Over 900 hygiene bags were packed to be used by homeless ministries across the state.

RA Camp-O-Ree – Over 450 boys and leaders attended the 2018 RA Camp-O-Ree at Linden Valley Baptist Conference Center on October 19-21. This missions camping event for boys grades 1-12 is hosted by Mid-South Royal Ambassadors and Tennessee WMU. Boys participated in a multitude of activities, challenges, and crafts while enjoying the great outdoors, meeting missionaries, and enjoying two action packed worship services.

RA Wilderness Challenge – Over 100 RAs and leaders attended the 2019 RA Wilderness Challenge, a missions camping event for boys in grades 1-12 hosted by Nashville Baptist Association and Tennessee WMU, held April 12-14, 2019 at Boxwell Reservation, Lebanon. Boys competed in various skill elements and competitions, learned about Bible Telling, and enjoyed two worship services.

Get-Together & Connection – Get-Together, a missions event for women, and Connection, a missions event for girls in grades 7-12, were held on April 5-7, 2019 at the Gatlinburg Convention Center. The 1,557 women, girls, and personnel attending the events participated in four worship sessions, a missions fair with over 40 exhibitors, and eight conferences. Participants donated over 22,000 washcloths, toiletry items, toilet paper, and feminine hygiene products to be given to Tennessee ministries serving refugees.

MINISTRY OPPORTUNITIES

Literacy Missions

Literacy Missions ministries are helping bring Tennesseans to Christ. There are 63 "registered" churches/associations English as a Second Language (ESL), Adult Reading & Writing (ARW), or Tutoring Children & Youth (TCY) ministry sites. These sites reported having participants from more than 25 countries, speaking 11 different languages who are being taught English and are engaged with the gospel. We have seven state trainers available to lead workshops to equip ministry leaders.

Reaching Refugees in Tennessee

The WMU social issue for 2018-22 is Project HELP: Refugees. A Reaching Refugees in Tennessee Task Force was formed and began meeting to identify specific needs of refugees in Tennessee, resources that are available and others that are needed, ministries that are already serving refugees in Tennessee, and materials to develop to educate churches and associations about needs/ways to serve and pray.

Christian Women's/Men's Job Corps

Christian Women's Job Corps and Christian Men's Job Corps are ministries of WMU that seek to help men and women break the cycle of poverty through job and life skill classes, Bible study, and mentoring. Last year the 25 sites in Tennessee reported serving 688 participants, with an additional 3,510 participating while incarcerated. There were 121 men and women who completed the program and 53 recorded professions of faith.

Children's Missions Day

Eight Tennessee churches and associations reported participating in the national Children's Missions Day in February 2019. Children's missions groups shared God's love through a wide range of projects including: serving in retirement homes, visiting neighborhoods, creating blessing bags for nurses and community helpers, making cards and cookies for nursing home residents, baking cookies for local emergency personnel, and serving the homeless population in communities across the state.

MISSIONARY CARE

Missionary Parents Fellowship

On September 7-8, 2018, 16 parents of IMB missionaries gathered with program personnel for fellowship, information, prayer, and encouragement at Immanuel Baptist Church in Lebanon. Special guests included Sharon Pumpelly, IMB Alumni and Parents of Field Personnel Mobilization Team, and David & Laura Dawkins, IMB missionaries serving in Europe, and their three sons.

Christmas Checks

In December 2018, Tennessee WMU mailed Christmas Checks, on behalf of Tennessee Baptists to missionary kids and retired missionaries.

Checks for \$150 were sent to 24 missionary kids whose parents serve with IMB and are from Tennessee.

Checks for \$50 were sent to 99 retired IMB missionaries who were born in Tennessee.

These gifts are made possible through an allocation from the Golden Offering for Tennessee Missions for nurturing Tennessee missionaries and their families.

MK Re-Entry Retreat

Six missionary kids from Tennessee were provided travel assistance funds to attend the MK Re-Entry Retreat August 6-9, 2019 hosted by Louisiana WMU and the International Mission Board.

ADDITIONAL AREAS OF EMPHASIS

Golden Offering for Tennessee Missions

The theme for the 2018-19 Tennessee Missions Emphasis was "Pursue the One." The suggested dates for the Week of Prayer for State Missions were September 9-16, and the goal for the 2018-19 Golden Offering for Tennessee Missions was \$2,100,000. As of July 24, 2019, the total amount given to the 2018-19 Golden Offering is \$1,827,473.18. The offering year goes from September 1 – August 31.

The LINK

As of September 2018, the Tennessee WMU newsletter, *The LINK*, is a digital-only publication and is delivered directly via email. This allows anyone to receive the latest news and happenings in Tennessee WMU, and not just church and associational WMU leaders. This change also allows funds traditionally used for printing and postage to be used for other WMU ministries.

State Acteens Advisory Panel

Each year Tennessee WMU selects three to six outstanding high school girls to serve on the state panel to assist with planning Connection, write articles for Tennessee WMU publications, and aid with other state events throughout their year of service. The members of the 2018-19 State Acteens Advisory Panelists are Grace Clouse, Cookeville; Amanda Huggins, Erwin; SandiGlen Jones, Sevierville.

Scholarships

In April 2019, \$39,200 in scholarships were awarded to 38 students attending graduate school, seminary, as well as, undergraduate schools in Tennessee during the 2019-20 school year. These scholarships are funded through endowments, invested funds, and the Golden Offering for Tennessee Missions.

BAPTIST & REFLECTOR

The *Baptist and Reflector* continues to strive to produce articles and columns that impact Tennessee Baptist Convention churches. A major emphasis this year has been a focus on state laws regarding abortion and sanctity of life issues. The paper provided extensive coverage of the I Stand for Life Initiative launched by the Tennessee Baptist Mission Board in July.

Also in 2019, the *B&R* ran stories on how churches can minister to families with special needs children and articles and columns on the increasing need of ministry to families affected by Alzheimer's disease or dementia. The paper also has emphasized the ministry of bivocational pastors and Vacation Bible School.

The B&R is mailed to more than 19,500 homes 26 weeks a year, reaching nearly 50,000 readers.

In addition, the *B&R* website has grown steadily since it was introduced in late 2015. From January through mid-July of this year we have had 132,750 sessions with 83,680 visitors and 211,650 page views, all up significantly over the same time frame last year.

The goal of the paper is to "tell the story of Tennessee Baptists" through news, feature stories and photographs. As in the past, the paper this year placed a major emphasis on what Tennessee Baptists are doing to reach the world for Christ by focusing on stories related to missions and evangelism. This year the paper has focused on timely topics such as domestic violence that impact Tennessee Baptists and our churches.

The *Baptist and Reflector* continued to utilize social media tools in 2019 such as Twitter. Editor Lonnie Wilkey regularly writes a blog that provides information for Tennessee Baptists between print issues.

The staff monitors trends that could affect Tennessee Baptists and prints those stories to keep readers informed. In addition, opinions, both from the editor and others, are printed and are intended to make readers think, reflect, and act.

The paper continually seeks to enlist new subscribers. The Church Trial Plan has been reintroduced. We need more churches to send the paper to their leadership such as deacons, Sunday School teachers, etc. We are asking every reader of the B&R for the next year to consider sending one subscription to someone they know. If just a small percentage of our readers would do this, our print circulation would significantly increase. NORTH AMERICAN MISSION BOARD (NAMB)

Everything we do at the North American Mission Board (NAMB) is about sending the hope of the Gospel. We want to celebrate the remarkable way God provided through the Annie Armstrong Easter Offering. Southern Baptists gave a record \$61.1 million to the offering, an all-time high.

NAMB launched a new Evangelism and Leadership group in 2018 designed to equip and encourage pastors as they mobilize their churches and take the hope of the gospel to the world around them. This group is led by long-time pastor Johnny Hunt. 2018 was marked by tragedy for many in North America who were impacted by hurricanes, floods, fires and other disasters.

NAMB—under our ministry assignment to coordinate disaster relief on behalf of Southern Baptists at the national level—supported dozens of state convention disaster relief units as they mobilized thousands of Southern Baptist Disaster Relief-trained volunteers and hundreds of pieces of equipment.

In addition, NAMB's Send Relief ministry is continuing to resource those who send help and send hope. Our Puerto Rico rebuild effort has hosted hundreds of volunteers as residents continue to recover from Hurricane Maria which struck in 2017.

In addition to crisis response, Send Relief is giving churches the opportunity to serve in areas such as poverty, refugees and internationals, adoption and foster care, human trafficking and more. There are currently five Send Relief ministry hubs (Appalachia, Atlanta, Las Vegas, New Orleans, New York and Puerto Rico) that are meeting needs in specific regions and giving Southern Baptists from all over North America opportunities to serve in long- or short-term settings. Through Send Network, NAMB helps Southern Baptists plant churches everywhere for everyone in North America. We have a special focus outside the South, where Southern Baptists are weakest, and in our cities where more than 80 percent of North Americans live. Planting evangelistic churches is the best way to introduce people to Jesus and grow them strong in their faith. Southern Baptists need to start about 1,200 churches annually to keep up with population growth and offset churches that are dying.

- Thanks to Southern Baptist giving, we are able to resource and support more than 5,200 missionaries.
- Southern Baptists added 975 new congregations in 2017, the most recent year for which data is available. This includes 691 new church starts and 284 new affiliations.
- Our goal is healthy, evangelistic church plants and the data points to success. As a whole, church plants are running 67 percent ahead of established churches in attendee to baptism ratio. In Canada, 71 percent of all baptisms came from churches started since 2010.
- Our Disciple-making Task Force reported its findings at SBC 2018 in Dallas. You can view the team's report and recommendations here. In addition, we are embracing recommendations made by members of the Evangelism Task Force as they were adopted by messengers at the SBC Annual Meeting in Dallas.

Mississippi River Ministry (MRM) is one of three arms of the Compassion Ministry outreach of the Tennessee Baptist Mission Board. During this past year, Over \$12,700 of GOTM funds were channeled into five different West Tennessee associations to assist churches with projects and ministries designed to impact lostness by touching poverty. I conducted thirteen (13) training events for over 625 participants in poverty training. Over 1,250 Christmas backpacks were collected and distributed to ministry sites in West Tennessee.

Tennessee responded well to the collection and distribution of Christmas backpacks last year. This year, the emphasis received additional attention at the WMU Gatlinburg Get-Together with the promotion of Tennessee's own video. Last year, a goal of 2,000 backpacks was exceeded and over 3,500 were received. And yet, we distributed over 15,000 Christmas Backpacks having received most of them from other states. This year our goal is 5,000 and many churches are beginning to join in the effort. These backpacks stay in Tennessee and touch of lives of needy children in our own communities. Today, more churches are needed to reach the underserved affected by poverty in their community. Mississippi River Ministry can assist in four ways:

1. MINISTRY PROJECT FUNDING

MRM channels *Golden Offering for Tennessee Missions* funds through churches and associations for specific ministry projects impacting poverty.

2. MATERIAL RESOURCE CHANNELING

MRM channels donations of material resources into ministry sites and churches to be used in Compassion Ministry.

3. COMPASSION MINISTRY COACHING & TRAINING

MRM provides church consultations and multiple training events and classes that help churches engage in ministry to the impoverished. This year, 15 training events were conducted.

4. VOLUNTEER MOBILIZATION

MRM facilitates placing volunteers from Churches to ministry sites in West TN.
