Mrs. Rachel Marie Duck was born on March 13, 1952 in Reagan, TN, the daughter of a Baptist pastor. She was an active member of First Baptist Church Dyer. She went home to be with our Lord on August 12, 2020, at Jackson Madison County General Hospital. She was married to Bro. Daymond Duck and served alongside of him in his ministry. Rachel graduated valedictorian of her class at Clarksburg High School in 1970. Rachel always had a heart for helping others and so she pursued a degree in Nursing at Union University and graduated in 1973 with an associate degree. She was a nurse, and her favorite role was when she was a head nurse at Jackson Madison County General Hospital. She left the hospital and started doing Home Health for West Tennessee Healthcare in 1991 until her retirement in 2005. She led multiple Bible studies, was involved in local missions, helped with Tanya Taylor mission fundraising, and taught Sunday School. She participated in multiple mission trips to Ecuador doing medical missions.



In Honor of Bro. Johnny Criswell

Bro. Johnny Criswell married his bride, Vickie on February 8, 1964. He surrendered to the gospel ministry at a revival in August of 1967 at Midway Baptist Church. He began his studies at Union University shortly thereafter in 1968. His first pastorate was the Fulton Baptist Church, Ripley, TN. He was paid \$25 a week and drove 160 each week. He graduated Union with a master's degree in religion and journalism in 1972. His next pastorate was First Baptist Church Maury City. At this pastorate a revival movement broke out with 67 salvations and 17 by letter his first year. Afterwards, he was called as pastor of Alridge Baptist Church. Bro. Johnny helped organize the Keely Mill Baptist Church in Dyer. He then pastored Poplar Springs Baptist Church. In 1991, he became the interim pastor of Midway Baptist Church and was called as pastor in 1992. He has completed twenty-eight years (28) at Midway and is the longest serving pastor in the Gibson Baptist Association at one church.

Special Called Executive Board Meeting

Ninety-Seventh Annual Session

First Baptist Church, Kenton TN - October 22, 2020

1. Call to Order – The meeting was called to order at 6:30 by Bro. Steve Littleton, moderator, pastor Gibson Baptist Church. There were 34 Executive Board Members, representing 21 churches, present.
2. Welcome and Prayer – Bro. Shawn Allred, pastor FBC Kenton, gave the welcome and opening prayer.
3. Financial Report – Mr. Jim Acree, Treasurer, member of FBC Dyer, said that we are in the black even with all that has gone on this year. We actually spent less than was budgeted for the year. We did not meet the budget in terms of receipts, but we did not spend more than we received.
4. Nominating Report – Pat Wollam, a member of Salem Baptist Church, recommended approval of the nominating committee report. There were no further nominations from the floor. The nominating committee was approved.
5. Budget Presentation – Charles Tyner, chairman of the budget committee, a member of Immanuel Baptist Church, presented the proposed budget. He stated that the budget reflects an increase of .22%. He recommended that the budget be adopted as presented by the Budget Committee. The proposed budget passed unanimously.
6. Miscellaneous Business – James Rogers, pastor of Oakwood Baptist Church, presented a recommendation from the Credentials Committee that Elevate Church in Milan be placed under watch care for the next year. The recommendation passed unanimously. He presented the next item of miscellaneous business, which was a proposed amendment to Article I, Membership, Section 2. The items to be changed were C, F, I and J. The recommendation passed unanimously.

Amendment To Bylaws: Article I. Membership, Section 2

- A. A church desiring membership in the Gibson Baptist Association shall write an official letter of petition, complete an application for membership and submit the letter with the application to the Director of Missions or the Moderator of the Association.
- B. The Credentials Committee shall serve as a watch care committee for the Association when a church petitions membership.
- C. The Credentials Committee shall meet with the petitioning church to examine their soundness of faith and doctrine, their intent to cooperate with sister churches of the Association, and their relationship with the Tennessee Baptist Convention and Southern Baptist Convention. **This watch care process shall be no less than six months.**
- D. Any church requesting membership must affirm the Baptist Faith & Message 2000 and be of like Faith and Order.
- E. It is recommended that the petitioning church have a sponsoring Southern Baptist church of like faith and order. The petitioning church shall have affiliation with no other denominational body.
- F. Only duly organized and constituted churches shall be considered for membership in the Association. New church plants or mission congregations may petition the Association for membership, provided that their sponsoring church has duly organized and constituted them as a church. The leadership of the new church plant or mission congregation shall meet with the Credentials Committee to verify their agreement and compliance with all requirements. ~~The new church may be recommended and accepted for membership at the annual meeting of the Association without the one-year watch care period since the sponsoring church has fulfilled this role and requirement.~~ **The new church, after having been under the watch care of the sponsoring church, may be accepted for membership by vote of the Association.**
- G. The petitioning church is required to participate financially to the Association and Cooperative Program during the watch care period.

- H. Members of the petitioning church are encouraged to participate in all programs, ministries, activities, Executive Board meetings and fellowship of the Association during the watch care period, but they have no voting rights and may not serve in any elected position of the Association.
 - I. ~~A church which was constituted and organized from division and disharmony with a sister church, shall work with the Credentials Committee to seek reconciliation and unity. The Credentials Committee and the leadership of the two churches shall work together to resolve any differences that might be an obstacle to the petitioning church's request for membership. A favorable recommendation will not be possible from the Credentials Committee until such time the two churches resolve their differences and demonstrate a spirit of unity and cooperation.~~
The Credentials Committee will work with the leadership of a church which was constituted and organized from division or disharmony and with the leadership of the sister church. The purpose will be to seek a healthy working relationship and a spirit of cooperation between the two churches, the Association, and for the Kingdom's sake. If there are no issues that require a meeting, then a letter of cooperation from the leadership of the two churches shall be acceptable.
 - J. The Credentials Committee shall report to the Association **its recommendation at the next meeting after the watch care process has been completed.** ~~at the next annual meeting its recommendation to receive or reject the petition for membership.~~ A three-fourths (3/4) vote is required for membership. If received as a member of the Gibson Baptist Association, the petitioning church shall be seated as messengers immediately and enjoy membership with all privileges and responsibilities as a sister church.
7. Seek Team – Bro. Bryan Morris, team leader, pastor of New Hope Baptist Church, said that the Seek Team wanted to focus on three (3) areas: Evangelism Training, Carnival Workers Evangelism Outreach at the Gibson County Fair, and an Impact Evangelism Event during the county fair. He also mentioned support for the West Tennessee Evangelism Rally in March.
 8. Strengthen Team—Shawn Allred, team leader, pastor FBC Kenton, gave the report. He stated that scholarships are available for continuing education. He gave dates for the pastors and wives retreat weekend, which will be March 5-6, 2021. He also talked about the Senior Adult activity on April 13, and the Youth Rally, during the Fair, on August 24, 2021.
 9. Send Team – Sheilah Spangler, WMU Director, member of Salem Baptist Church, gave the report due to the absence of team leader, Eric McLemore. The send team made the recommendation that our new Wingo goal be \$23,500 and be distributed as follows:
 - 70% to IMB, which is a 5% decrease
 - 25% to NAMB, which is a 5% increase and
 - 5% to Disaster Relief Team.
 The recommendation passed unanimously.
 10. WMU Report – Sheilah Spangler, WMU Director, informed the board that mission work has continued, even with Covid, through our offerings.
 11. Election of Officers – Bro. Steve Littleton, moderator, opened the floor for nominations for each office. Bro. James Rogers, pastor of Oakwood nominated Bro. Shawn Allred, pastor of FBC Kenton as moderator, and Bro. Andy King, interim pastor of Fruitland, moved that nominations cease, and Bro. Allred be elected. The motion was approved, and Bro. Shawn Allred was elected moderator. Bro. David Powell, pastor of Smyrna Baptist Church, nominated Bro. Bryan Morris, pastor of New Hope, as assistant moderator. Bro. Shawn Allred moved that nominations cease, and Bro. Morris be elected. The motion passed and Bro. Morris was elected assistant moderator. Bro. Andy King nominated Leann Cherry as clerk. Bro. Jason Bowen, pastor of FBC Trenton moved that nominations cease and she be elected. The motion passed and she was elected. Doug Duncan, member of FBC Dyer, nominated Jim Acree, member of FBC Dyer as treasurer. Bro. Shawn moved that nominations cease,

and he be elected. The motion passed and he was elected. Pat Wollam, member of Salem Baptist, nominated Bro. Joel Pigg, pastor of Salem Baptist, as assistant treasurer and Bro. Andy King moved that nominations cease. The motion passed and he was elected.

12. Time, Place Resolution Report – John Coleman, pastor of New Bethlehem Baptist Church, recommended that the 2021 Annual Meeting of the Gibson Baptist Association be held on October 25, 2021, with the host church being New Bethlehem Baptist Church. The recommendation passed. The second recommendation was for the approval of the resolutions (see below). The resolutions were adopted unanimously. After the resolutions passed Bro. Andy King requested that Resolution 4 be sent to the Executive Committee of the Southern Baptist Convention.

EXECUTIVE BOARD REPORT

The Executive Board of the Gibson Baptist Association is composed of one elected representative from each church and the pastor of the church. The Constitution and Bylaws require the board to meet quarterly. The Executive Board has as its purpose to conduct the business of the association between annual meetings.

January Executive Board Meeting highlights: Twenty-two members, representing 13 churches were present for the first meeting of the year. Moderator Steve Littleton recognized new pastors Jim Koonce, interim pastor Connect, and Kevin Mullins at White Hall. Treasurer Jim Acree presented the financial report. He shared that receipts were about \$851 less than expenditures, but still in line with the budget. Bro. Roger Stacy announced that no one applied for the Bertie Thompson scholarship this year. Christian Women's Job Corps has completed the process to incorporate as a 501c3 and will no longer be under the liability umbrella of the GBA. He observed that several churches, some large, are in conflict, that affects the monetary support given to the Associational work. He encouraged all churches to remain faithful to the giving. Bro. Randy Pool, representing TBMB recognized Calvary Rutherford as the #3 (2017) and #2 rank (2018) in Cooperative Program giving per attendee. Bro. Sammy Dowland, pastor, received the award for the church. Kelly Wall, Director, Gibson County Birth Choice, reported that they now have a Mobile Unit and will serve Fayette, Hardeman and Haywood Counties. She stated 72%-80% of abortion-minded women change their minds after hearing the heartbeat. Sheilah Spangler presented the WMU report highlighting the Annual Jerry Legg Volunteer Mission Banquet/Cornbread and Bean Supper, at Salem on February 20 at 6:30 pm. She also highlighted the Missions Get-Together for women at Gatlinburg March 20-22. Christy Skelton updated the progress on the transition house (House of Hope). They still need a house manager. The women will most likely be residents for 6-12 months. Six churches have committed to \$100 monthly support. Twice Blessed Thrift Store profits help greatly but will not be sufficient to fund the house entirely.

July Executive Board Meeting highlights: Jim Acree, treasurer, gave the financial report stating receipts are short of the budget. We received \$149,388.03 but our expenditures were only \$136,263.88. Bro. Roger Stacy, DOM, shared that Maranatha Baptist Church in Humboldt has decided to dissolve and give their building to GBA. They also are giving the association \$25,000 to help pay for utilities and upkeep of the building and property. He shared he will be working with The Church at SugarCreek to use the building for the Hispanic ministry. He asked the board to consider a contingency plan if we are not able to have our annual meeting in October. In miscellaneous business the board adopted a contingency plan regarding the annual meeting.

- (1) The board desires to have the annual meeting, if possible, at its regular date, time, and place. October 26, 2020, at Antioch Baptist Church. If it is deemed, solely by the discretion of the GBA Leadership team, unfeasible or irresponsible to hold the annual meeting due to the ongoing pandemic of COVID 19, will trigger the following contingencies as deemed necessary.
- (2) Hold a special Called Executive Board meeting to approve officers, committees, and team members for the new church year. The nominating committee will make its recommendations to the executive board for approval. The budget and finance committee will present a budget for approval to the executive board. This option gives the most significant opportunity for input, next to having the annual meeting, in the decision-making process.
- (3) Deeming option 1 or 2 to be unfeasible or irresponsible and in the unlikely event the nominating committee and the budget finance committee are unable to provide recommendations for officers, committees, and team members, and budget the executive board has chosen to adopt the current budget for the new associational year, October 1, 2020-September 30, 2020, and approve the current officers, committees, and teams to serve for another year until the next annual meeting of the association.

DIRECTOR OF MISSIONS REPORT

(ASSOCIATIONAL MISSIONARY)

This has been the most unusual year in my life and my ministry. Most of what we planned a year ago to accomplish has not been done due to the Covid-19 pandemic. Our teams met and planned diligently for a great year of ministry, but most of those plans had to be put on hold. I am prayerful and hopeful we can move forward this year with doing great things for God!

We welcomed a new Ministry Specialist on January 6, 2020. Grace Gentry began her ministry with the Gibson Baptist Association. Her e-mail address is: gbams1@gbalife.org.

The only mission trip to Brazil this year was the week of February 3—11. Again, this was due to the coronavirus pandemic. A team of 18 volunteers served in Rio de Janeiro, Brazil and conducted simultaneous revivals (a crusade) in 12 churches during the week. I am thankful for the Wingo Funds providing scholarships for pastors to be able to go and preach in the churches in Rio. There were 389 professions of faith during the crusade. We saw many drug dealers surrender their lives to the gospel. A highlight of the trip was to be hosted by the mayor of Rio and not only enjoy a meal with him, but to lay hands on him and pray for him.

We were able to have our Jerry Legg Volunteer Missions Banquet before Covid-19 hit. Barbara Jones, member of Salem, received the award for Volunteer of the Year.

This year the Association had to make some adjustments to have the Good Friday services. We had planned on Smyrna Baptist Church to host the event, but due to Covid-19, we had to go virtual. The *“Seven Saying From The Cross”* were preached by seven pastors using Facebook to stream the sermons.

As we hit the spring and into the summer, most of our churches ceased to have in-person services. Many provided drive-in church services, Facebook live, YouTube or other livestreaming means to continue to worship. This has been a very difficult season for our pastors and wives.

Members of our Strengthen Team and I attended a Replant Conference offered by the North American Mission Board the week of March 2-3. The Replant Conference was a two-day training of association teams to help churches facing closure. This is a growing issue across the Southern Baptist Convention.

Through our mission work in Brazil, we have worked with Silvia Crespo, a Brazilian who is rescuing street children. I made an appeal to help her financially to have funds to feed 120 children who are homeless and whose parents are either drug dealers or prostitutes. I want to thank our association of churches and individuals for your generous offerings. We have received over \$5,000. Funds keep coming in for this ministry. Silva reported to me that five entire families have been saved and baptized as a result of your offerings.

It saddens me to report that Maranatha Baptist Church in Humboldt voted to close its doors. Connect Baptist Church in Milan also closed its doors. Members of Connect merged with Elevate Church. Elevate purchased the church building. Elevate is a Tennessee Baptist Convention at-large church. Both churches could not recover from the drop-off in attendance due to Covid-19. Both churches are giving the funds in their checking and savings accounts to our association. Our plan is to use the Maranatha Baptist Church building for the Hispanic ministry in Humboldt, working with the Church at SugarCreek.

My prayer is that we will soon turn the corner on the Covid-19 pandemic and that we will experience the greatest year in our history as Gibson Baptist Churches.

2020-2021 GUIDELINES FOR WINGO MISSION FUNDS

In order to receive Wingo Funds for any mission trip or project, all volunteers must undergo a background check with the GBA. This requirement is in compliance with our mission sending agencies of the Southern Baptist Convention, and is for the legal prudence of the GBA. No funds will be dispersed for any trip or project until the background screening requirements are completed and payment has been received.

BACKGROUND SCREENING REQUIREMENTS

- 1) Volunteers must submit three references using the reference forms provided by the GBA. The references must be from individuals who are not family members of the volunteers and must be at least 21 years of age. One of the three references must be from the pastor of the church where the volunteer is a member. In cases where the church is without a pastor, a staff member or chairman of deacons may serve as a reference.
- 2) Volunteers must complete a personal interview questionnaire form provided by the GBA.
- 3) Volunteers under the age 18 are only required to submit reference forms and the personal interview questionnaire.
- 4) Volunteers who are older than 18 must have a background check through the company used by the GBA. A consent form will be provided for the volunteer to grant permission for the background check.
- 5) The volunteer will be responsible for paying the fee for the background check.
- 6) Volunteers are required to watch a child protection video provided by the GBA.
- 7) Volunteers are required to undergo background screening every four years with the GBA.
- 8) Churches participating in a mission trip other than a GBA led trip, shall conduct the background screening as outlined above. All background screening forms shall be maintained on file with the church. GBA will make available online background checks for churches. When a church has completed the background screening, an authorized representative of the church must sign a declaration statement provided by GBA, verifying that the background screening has been completed for every mission volunteer receiving Wingo Funds. Background screenings are valid for four years. In cases where a church receives a Church Scholarship (Multiple Scholarship), the same procedures must be followed along with a signed declaration statement to the GBA. Wingo funds will not be granted until such procedures are completed.

INTERNATIONAL MISSIONS PROJECTS

GBA Volunteers and churches participating in an official project of the Gibson Baptist Association, the Tennessee Baptist Convention, or the International Mission Board are eligible for travel assistance from the Wingo Fund account. Scholarships from this account primarily seek to encourage and help GBA volunteers (ages 15+ or a student who has completed 9th grade) to participate in a 'first time' mission trip. The following guidelines apply for use of Wingo Funds:

- 1) Funds are designed to assist volunteers who participate in an official IMB trip/project. First time international mission volunteers are eligible for a scholarship of \$400.
- 2) Volunteers who have previously participated in an official IMB project/trip are eligible for a \$300 scholarship once per associational calendar year, if it is an IMB project/trip.
- 3) Churches may request a multiple scholarship for volunteer team members of the same church once per calendar yr.
 - A multiple scholarship is designated when a group of volunteers from a single church participate in same project/trip.
 - A multiple scholarship amount will be limited to \$2,000 for the project/trip.
 - Only one multiple scholarship can be granted to a single church in the calendar year.
 - Additional scholarships may be awarded to other individuals of a church that has received a multiple scholarship (under existing guidelines) up to \$1,000 over and above the multiple scholarship.
 - Scholarship requests that exceed the \$3,000 limit for a church may be considered by the Send Team.
 - It is encouraged that first time volunteers be distributed their full \$400 scholarship from this amount, if possible.
- 4) Volunteers (first time or otherwise) not participating in a multiple scholarship project/trip with their church are still eligible for an individual scholarship once during the association calendar year.
- 5) Volunteers requesting funds must complete an application, available at the GBA office or by e-mail.
- 6) Wingo funds will be disbursed as early as possible with adequate notice prior to the date of the project/trip. Special considerations may be submitted to GBA.
- 7) Any special requests/needs for funds not addressed in these guidelines may be addressed to the necessary channel of the Send Team.
- 8) In order to help and encourage pastors who have never participated in an IMB international mission trip while serving as a GBA pastor, a \$ 1,000 pastor's scholarship will be available for five pastors each year (first come, first serve basis). To qualify, this must be the pastor's first IMB international mission trip as a GBA pastor. The

pastor will still be eligible to receive Wingo funds for first-time mission volunteers along with this scholarship. It must be an official trip of the International Mission Board and be in compliance with all guidelines for Wingo mission funds.

DISASTER RELIEF PROJECTS

- 1) International disaster relief projects will qualify for travel assistance for GBA volunteers as listed above. However, for International Disaster Relief Projects, the minimum amount from this fund shall be \$500 for any volunteer from GBA, regardless of the number of trips/projects the volunteer may have participated in.
- 2) Matching funds from the local church is encouraged.
- 3) The maximum total contribution to volunteers from a single church for any specific project/trip travel assistance is \$2,000.
- 4) USA disaster relief projects qualify for gasoline reimbursement for volunteers from GBA going to a disaster point as called upon by the GBA or TBC.
- 5) An allocation of up to \$1,000 may be given to any area where a disaster has occurred. The gift and amount is to be determined by the Send Team of the association.

NORTH AMERICAN MISSIONS PROJECTS

GBA Volunteers and churches participating in an official project of the Gibson Baptist Association, the Tennessee Baptist Convention, or the North American Mission Board are eligible for travel assistance from the Wingo Fund account. Scholarships from this account primarily seek to encourage and help GBA volunteers (ages 13 and older or a student who has completed 7th grade) to participate in a 'first time' mission trip. The following guidelines apply for use of Wingo Funds:

- 1) Funds are designed to assist volunteers who participate in an official GBA, TBC, or NAMB trip/project more than 200 miles round trip from the Gibson Baptist Association Office out of state. First Time North American mission volunteers are eligible for a scholarship of \$150.
- 2) Volunteers who have previously participated in an official North American Mission project/trip are eligible for a \$100 scholarship once per associational calendar year, if it is a North American Mission project/trip.
- 3) Churches may request a multiple scholarship for volunteer team members of same church once in the calendar year.
 - A multiple scholarship is designated when a group of volunteers from a single church participate in the same project/trip.
 - A multiple scholarship amount will be limited to \$1,000 for the project/trip.
 - Only one multiple scholarship can be granted to a single church in the calendar year.
 - Additional scholarships may be awarded to other individuals of a church that has received a multiple scholarship (under existing guideline) up to \$375 over and above the multiple scholarship.
 - Scholarship requests that exceed the \$1,375 limit for a church may be considered by the Send Team.
 - It is encouraged that first time volunteers be distributed their full \$150 scholarship from this amount, if possible.
- 4) Volunteers (first time or otherwise) not participating in a multiple scholarship project/trip with their church are still eligible for an individual scholarship once during the association calendar year.
- 5) Volunteers requesting funds must complete an application which is available at the GBA office or by e- mail.
- 6) Wingo funds will be disbursed as early as possible with adequate notice prior to the date of the project/trip. Special considerations may be submitted to GBA.
- 7) Any special requests/needs for funds not addressed in these guidelines may be addressed to the necessary channel of the Send Team.

WINGO OFFERING

Each year the Send Team of the association will recommend a goal for the Wingo Offering at the Annual Meeting of the GBA. Gifts from churches or individuals for these accounts are welcomed anytime during the budget year. However, a recommended date for receiving the Wingo Offering in the churches is the last Sunday of each month, May through September each year. Fund allocations from donations/offering will be determined by the Send Team each year. The Wingo Offering is named in honor of Rev. Charles Wingo, first Director of Missions, GBA. Wingo Funds exist to encourage volunteers and church participation.

SEND TEAM

Wingo Fund Report

This year the Wingo offering goal was set at \$23,000. Our GBA churches gave a total of \$20,849.39, which was short of our goal by \$2,150.61. Last year our churches gave \$21,744.39, plus another \$911.00 received during the Annual Meeting, bringing the grand total to \$22,655.39. The Wingo funds are used to assist volunteers in participating in mission projects and trips during the year. We are thankful for our churches and individuals who give faithfully to support missions and the Wingo offering.

Wingo Funds were used this past year to help eighteen (18) individuals from thirteen (13) churches receive Wingo scholarships that helped with the cost of their mission trips to three (3) countries. Last year forty (40) volunteers from twelve (12) churches received Wingo funds to travel to three (3) countries.

The total, GBA/IMB scholarships distributed this past year, was \$12,300. The following is a list of those receiving funds and the country in which they served.

Brazil Mission Report

Due to the covid-19 pandemic, we were not able to take but one team to Brazil this past association year. We hope that the next year will bring new opportunities to resume our partnership with Brazil.

We were able to lead a team of pastors along with some lay people to conduct a crusade in the northern part of Rio de Janeiro, Brazil. Pastor Douglas Xavier spoke at our annual association meeting last October and in several churches, along with speaking to our pastor's conference. His challenge was for us to take a group of preachers to Rio to conduct a crusade (simultaneous revivals).

The week of February 3-11, 2020, twelve preachers scattered out across the area known as Chapadão to preach in twelve (12) churches. When we arrived in Rio, we were taken to the mayor of Rio's palace to meet him and enjoy a meal with him and his staff. We were able to present him a plaque on behalf of the Gibson Baptist Association. In return, the mayor presented our association with a gift. The evening of our arrival we participated in a rally to kick off the week of revivals. Pastor Douglas hosted the rally with the presence of the pastors from the twelve churches.

One of the highlights of the week was the opportunity to go to the headquarters of the drug lord. With around 10,000 young people gathering for an evening of drugs and a party life, we were given the opportunity to have prayer and through the prayer share the gospel of Jesus Christ.

The last Sunday afternoon of the crusade (revivals) there was a big rally with all of the pastors and churches. Bro. Bryan Morris preached the message for the afternoon.

When the week of revivals came to an end on Sunday evening, the team rejoiced that 389 souls made professions of faith. Churches were strengthened and pastors were encouraged.

We plan on going back to Brazil in 2021 to conduct another crusade if the covid-19 crisis is under control.

The Wingo funds have provided financial help to many of our pastors to participate in mission trips to Brazil.

Join us this next year and help us reach Brazil with the gospel in 2021!

Ohio Mission Report

Virtually all mission work and mission teams were unable to respond to our partner's needs in the West Central Baptist Association, Piqua, Ohio.

The need is great, and the workers are few. The association covers ten (10) counties with over 550,000 residents. There are only 14 Southern Baptist Churches in these ten counties that compose the association.

We have worked with the West Central Association in the towns of Minster and New Bremen to help plant a church. Other areas of the association are also in need of teams and volunteers.

One of our greatest strategies is prayer for the lost and for an openness to the gospel. We are asking God for a person of peace or people of peace. This is a key to opening the work up for a new church plant.

The Hillcrest Baptist Church in the West Central Association is the sponsoring church of this new work.

We are prayerful that next year we will be able to return to Ohio with mission teams.

Baptist Collegiate Ministry Report

Our year started out great working with the Dyersburg State Trenton Campus. We had meals prepared by local churches every 1st and 3rd Monday of the month during the Fall and Spring semesters. Obviously, the COVID-19 crisis changed everything during the Spring semester. Dyersburg State went virtual and that left us with no ability to minister to these students for the remainder of the year. We hope that will not be the case this next year.

I would like to give a big thank you to all of the churches that helped us out by preparing meals and giving donations to help provide for this great ministry. We typically averaged around 20 students for each gathering. During each meal there was a sermon preached. The students were very grateful for the meals they received and were very respectful to everyone present. I was able to develop some nice relationships with the students. On a couple of occasions I stayed a couple of hours after each meal was over. The students were asking a lot of deep questions and we would just sit and discuss whatever issue came up. Gibson Baptist Association WMU Annual Report

In September, I had the opportunity/privilege to represent GBA WMU at the TN Day at national WMU headquarters in Birmingham, AL. TN Day recognized the years of support that TN has provided to the national offices and it specifically unveiled the new TN room in their library. The library renovation is just one of the many projects undertaken by various state organizations to remodel the headquarters. I toured the headquarters and was fascinated by the museum of missionary mementoes prominently displayed throughout the building. At 94 years of age she had just stepped down from her position as the oldest serving member of the Leadership Team. We were so excited to honor her in this way. Contributions for the brick were made by individuals and churches throughout the association. Brother Roger was the speaker for that meeting and talked about mission trips to Brazil.

Also, in September the Missions & Ministries coordinators (Mindy Summar and Penny Stacy) organized the local churches to provide free snow cones in front of Twice Blessed on the 28th in celebration of Good Neighbor Day. All were encouraged to wear their church T-shirts and tracts were distributed to the community along with the snow cones. The community was very appreciative of this event.

Unfortunately, the rest of the year was lost to cancellations. However, the WMU leadership team held its yearly planning meeting in August to map out the 2020-2021 year. We pray that with God's guidance and direction some or all of our plans will be completed this next year.

Evangelism

Twenty-seven (27) GBA churches reported baptizing one hundred thirty-five (135) people this year. Last year thirty-three (33) GBA churches reported baptizing one hundred sixty-three (163) people. We baptized twenty-eight (28) fewer people this year.

Vacation Bible School Report

We were not able to have our Vacation Bible School training clinic this year due to the Covid-19 pandemic.

We are hopeful we can have our training next year. Churches are encouraged to have a Vacation Bible School this next year. If we do not reach children and youth with the gospel through VBS, we will perhaps never reach them as adults. VBS is the most effective tool the church has to reach the lost. Here are some helpful facts about Vacation Bible School based upon research from Lifeway:

- 25% of Baptisms reported by the Southern Baptist Convention come from VBS.
- Every 1 person trained in VBS results in 1.1 salvation decisions.
- VBS increases the number of prospects discovered from your community.
- 10% of people enrolled in VBS are unchurched.

Our Association Vacation Bible School team attended the training led by the Tennessee Baptist Convention at West Jackson Baptist Church.

The theme for the 2021 VBS is “Destination Dig, Unearthing the Truth about Jesus.” Kids will discover real-life archaeological finds that have helped to uncover the truth about Jesus. The theme verse is Jeremiah 29:13.

STRENGTHEN TEAM

Christian Women's Job Corps

We started out the new Association year very excited about all that God was doing in the ministry of Gibson County CWJC. In spite of all that is going on around us and the very challenging times that we are living in, we remain excited and dedicated to the mission of helping women to become successful and self-sufficient.

The Gibson County CWJC is your ministry. It belongs to the citizens of Gibson County. It is because of your overwhelming generosity, your hearts of servitude and your prayers that we continue to be able to minister to people in need, witness to the lost in our community and be good stewards of God's blessings and resources. This past church year we assisted over 100 families with food/clothing. We also processed 35 applications for assistance with their utilities through the Ministerial Alliance.

This past fall in August we started a new class at the Gibson County Correctional Facility. We simultaneously had a class going at Twice Blessed. From those two classes we had 3 graduates. Two of those graduates became volunteers at Twice Blessed, and one continues currently. One has just completed a 6-month rehab, and the other got a job. Our classes both at the jail and at Twice Blessed for the spring of 2020 were interrupted by the pandemic. We had 13 enrolled in our class at the Gibson County Correctional Facility and 3 in our class at Twice Blessed. We are not permitted to have classes at the jail and have chosen not to have any classes at Twice Blessed at this particular time.

Our Transition House is fully furnished and ready for occupancy. We were able to use our 2nd allocation of \$500 from our GOTM toward the liability insurance for our house. Our prayer is that in the very near future, this house will become a home for those women who sincerely need a fresh start. Please continue to pray regarding this endeavor.

In lieu of our Night of Hope this year, we will have a live auction on November 10th at 6pm. We hope to have a good selection of merchandise for your bidding pleasure. Please watch for more information and be prepared to shop for Christmas gifts as well as other nice items.

Because of your support we have been able to continue offering free ultrasound at our clinics and on our mobile unit as well as provide all our other free programs. God bless you.

Continuing Education Report

Continuing education is under the responsibility of the Strengthen Team of GBA.

Dr. Roger (Sing) Oldham is now working with the Tennessee Baptist Mission Board (TBC) to help initiate and facilitate continuing education across the state. One of the goals is to establish Bible Institutes or something similar in our associations.

This type of training will help prepare and develop lay leaders and pastors. The GBA Strengthen team will be considering the possibility of offering courses through a Bible Institute as we move forward with continuing education.

An option for continuing education has been around for many years and is known as Seminary Extension. Courses are available online for anyone desiring to receive credit for study or to study without seeking any degree. Our six Southern Baptist Seminaries provide this course of study.

Block Party Wagon Report

We are thankful for God's provision of a tremendous tool to reach communities for Christ through our Black Party Wagon (BPW).

We were not able to make full use of the Block Party Wagon (BPW) this year due to the coronavirus pandemic.

As you know the state of Tennessee passed a law governing the use of jumpers (bouncy houses), many associations ceased to have block party wagons. This also affected the use of our Block Party Wagon. We are hopeful that we can get the certification so that we can once again use the bouncy house.

The Block Party Wagon (BPW) is available for any GBA Church on a first-come-first-serve basis. The restriction is that it must be used in some form of evangelism outreach.

Sunday School Report

For the last several years, the Annual Church Profiles show that Sunday School attendance and enrollment have continued to drop. The annual church profiles for 2019/20 show that Sunday School enrollment decreased again. Our churches reported a Sunday School enrollment of 5,402 which is a decrease of 165 from last year's enrollment of 5,567. Our Sunday School average attendance also decreased by 325 people with the 2018/19 average attendance at 3,613 and the 2019/20 average attendance at 3,288.

Discipleship Training Report

Discipleship Training has increased this year from last year. This year nineteen (19) of our churches reported a total enrollment of 1,128 in Discipleship Training. Last year twenty-two (22) churches reported an enrollment of 1,081. The enrollment increased by 47 members.

Bible Drills Report

Like everything else in 2020, Bible Drills looked different. While we were not able to have associational or regional & state drills, several of our churches proceeded with their church drills in some form. The TBMB allowed us to count our church drills as if they were associational, regional and state drills. While we requested information from the churches in our association, we only received it from three churches. Following are the names of the children who participated, along with their grade, the number of years they have participated, and their standing. These children received their certificates, seals, and trophies and have been recognized by their churches. Thanks to all the Bible Drill coaches and especially to all the children who worked so hard to "hide God's Word in their hearts".

Baptist Memorial Health Care System

Memphis, Tennessee

Baptist Memorial Health Care began as a 150-bed hospital in downtown Memphis in 1912. It was formed by the Southern Baptist Conventions of Tennessee, Mississippi and Arkansas because they recognized a tremendous need for a health care facility in this part of the country. The hospital's early days were rough – at one point, it almost closed – but eventually it grew to become the largest private hospital in the world. The hospital played a very important role in the history of health care in the 20th century, celebrating many firsts along the way.

The Baptist Memorial Health Care system was created in 1981 to provide an integrated health care delivery system offering a full continuum of care to communities throughout the Mid-South. Today, a total of 22 hospitals in Arkansas, Tennessee and Mississippi; an 800-member physician group; and dozens of other entities are affiliated with Baptist.

Baptist Memorial Health Care's staff chaplains are a part of the health care team. Patients, family members or employees know that they can ask for a chaplain at any time to augment our health care with spiritual or emotional care. In our hospitals, our chaplains represent their own faith but often deal with spiritual issues that transcend denominational lines.

In August 2017, Baptist's Pastoral Care Department introduced the Rev. Jimmy Terry Preaching Series: It's All About Jesus. The series is named in memory of a beloved member of Baptist's Board of Trustees and the founder and former pastor of Tabernacle Baptist Church in Clarksville, Tennessee. Each month, a speaker – usually an ordained Baptist minister – delivers an evangelical message to employees, physicians, patients and visitors at Baptist's flagship hospital. The message is also broadcast to all 22 of Baptist's hospitals in Tennessee, Mississippi and Arkansas, and it is promoted on Baptist's Facebook page.

In the last half of 2019 and the beginning of this year, hundreds of people attended Jimmy Terry Preaching Series sermons in our Garrett Auditorium and hundreds more watched on monitors throughout our health care system. We post a video from each event on our Facebook page, and from June 2019 to February 2020, those videos have been viewed nearly 79,000 times and have reached more than 82,000 people.

Baptist Memorial Health Care has dedicated a considerable amount of time and resources to protecting our communities from COVID-19. Since the pandemic began, we have treated thousands of COVID patients in our hospitals and performed more than 160,000 tests. In addition, we launched a multi-phase public education campaign that included television public service announcements, billboards, social media ads and posts, videos and media interviews. Hundreds of thousands of people received important information about the virus and how to stay safe and healthy. We will continue this necessary work for as long as COVID-19 affects the people we serve.

The Center of Excellence for Addiction Medicine, a partnership between Baptist Memorial Health Care and Integrated Addiction Care (IAC) Associates – a medical practice that treats patients with addictions to drugs and/or alcohol – won a \$4 million, five-year Health Resources and Services Administration grant to expand its addiction medicine fellowship program. The fellowship program is one component of the Center of Excellence, and it focuses on training future addiction medicine physicians. The grant will allow the center to train five physicians a year for five years, adding 25 addiction medicine specialists to the Mid-South community.

Generous Baptist team members helped raise \$133,000 during the 2019 United Way Giving Campaign. The money will benefit the United Way Fund, the Baptist Memorial Health Care Foundation and other charities. Funds help provide grief support, financial assistance for patients and employees, health care for the homeless, scholarships for students training to be health care professionals and many others in the communities we serve.

Using data from the College Scorecard, an online database started in 2015 to give more information about colleges, Georgetown University published a report that ranks 4,500 colleges and universities by return on investment. Baptist College of Health Sciences was the number 1 private college in Tennessee and was in the top 10 percent of colleges nationwide.

In September, the Baptist Cancer Center was one of only six centers in the country to begin a research study called the SIMPRO Research Center. In collaboration with the National Cancer Institute and the Beau Biden Cancer Moonshot Initiative, the study will help researchers and technicians develop, implement and evaluate an app called eSyM. The app makes it easier for cancer patients to track and communicate their treatment symptoms to their care team.

Baptist Memorial Hospital-Tipton won a Breastfeeding, Early Elective Delivery Reduction and Safe Sleep for Tennessee Babies (BEST) Award for its efforts to reduce infant deaths in the state. The Tennessee Department of Health and the Tennessee Hospital Association bestowed the honor, which promotes safe sleep for infants and helps give Tennessee babies a great start to life.



For almost 200 years, Union University has been an institution that is committed to the local church, to the authority of Scripture, and to the preparation of young adults for a lifetime of service. Our mission statement expresses our objective:

“Union University provides Christ-centered education that promotes excellence and character development in service to Church and society.”

We fulfill that transformational mission through our commitment to four core values: Excellence-driven, Christ-centered, People-focused, Future-directed.

These values shape our identity as an institution that prioritizes liberal arts-based undergraduate education, enhanced by professional and graduate programs. The Union academic community is composed of quality faculty, staff and students working together in a caring, grace-filled environment conducive to the development of character, servant leadership, and cultural engagement.

We saw many examples of God’s faithfulness to Union during the 2019-2020 academic year. Our trustees approved a campus master plan that will guide development of Union’s physical campus over the next 20 years. A survey conducted by our Vocation Center for Life Calling and Career showed that 98 percent of Union’s class of 2019 were employed or enrolled in graduate school within six months of receiving their degree. The class of 2019 in our College of Pharmacy received a 100 percent pass rate for first-time attempts on the North American Pharmacist Licensure Examination. Union was one of only three pharmacy schools in the nation to achieve that (out of 140 schools total), and the only one in the Southeast to do so.

In addition, we announced several new majors that will begin in the 2020-2021 academic year, including cybersecurity, criminal justice, forensic science and commercial music.

While the COVID-19 pandemic disrupted much of our spring semester, the Lord provided for our needs. We were able to hold commencement ceremonies in June to celebrate our 2020 graduates, and we resume our in-class instruction for the fall semester.

We are pleased to be partners with the churches of Tennessee Baptist Mission Board and are immensely grateful for their support. Because of the generous support of Tennessee Baptists, Union is able to provide a transformative experience for our students. As Union University strives to be faithful to our mission in an age when traditional Christian beliefs are continually under assault, we value the ongoing prayers and support of our Tennessee Baptist partners.

The *Baptist and Reflector* continues to strive to produce articles and columns that impact Tennessee Baptist Convention churches. As with the rest of the world, one of our major emphases in 2020 has been publishing articles to help our churches deal with the COVID-19 crisis in our country. In addition, just before the pandemic started to peak in March, we provided extensive coverage of tornado damage through Middle Tennessee and later in the Chattanooga-Cleveland area of East Tennessee.

Also this year, the *B&R* is focusing on our 185th anniversary as a Baptist state paper. The paper was established in 1835 by Editor R.B.C. Howell, who also was the pastor of First Baptist Church, Nashville. The first issue of *THE BAPTIST* was published on Jan. 1 of that year. The paper would eventually become the present day *Baptist and Reflector*. It is one of the longest, continuously published papers in the United States.

The *B&R* is mailed to more than 18,300 homes 26 weeks a year, reaching nearly 50,000 readers.

In addition, the *B&R* website has grown steadily since it was introduced in late 2015. From January through mid-July of this year we have had 167,300 visitors and 343,900 page views. The number of visitors is more than double what the website had at the same time last year and the page views have increased by more than 140,000 over the same time frame.

The goal of the paper is to “tell the story of Tennessee Baptists” through news, feature stories and photographs. As in the past, the paper this year placed a major emphasis on what Tennessee Baptists are doing to reach the world for Christ by focusing on stories related to missions and evangelism. This year the paper has focused on timely topics such as domestic violence that impact Tennessee Baptists and our churches.

The *Baptist and Reflector* continued to utilize social media tools in 2020 such as Twitter and Facebook. Editor Lonnie Wilkey regularly writes a blog that provides information for Tennessee Baptists between print issues.

The staff monitors trends that could affect Tennessee Baptists and prints those stories to keep readers informed. In addition, opinions, both from the editor and others, are printed and are intended to make readers think, reflect, and act.

The paper continually seeks to enlist new subscribers. The Church Trial Plan has been reintroduced. We need more churches to send the paper to their leadership such as deacons, Sunday School teachers, etc. We are asking every reader of the *B&R* for the next year to consider sending one subscription to someone they know. If just a small percentage of our readers would do this, our print circulation would significantly increase. Associational Report 2020

Carson-Newman University

Your partnership and support enable us as Christian educators to help our students reach their full potential as educated citizens and worldwide servant-leaders.

This past year has included:

- The campus community began the year celebrating the University's new president Dr. Charles A. Fowler and his wife Sandra. The University held his inauguration where more than 40 academic institutions, associations and learned societies were represented. Inauguration events leading up to the ceremony featured speakers that included Dr. David Dockery, Dr. Tom Elliff and Dr. Randy Davis.
- Carson-Newman announced its largest freshman class in its history (557). It also marked its highest enrollment ever with 2,725 students and a record 885 graduate students.
- Partnering with the TBMB, C-N hosted "Tennessee Evangelism Rally," which drew more than 900 attendees from multiple churches across East Tennessee. The event featured Christian recording artist Christy Nockles, C-N alumnus Roc Collins and Christian music's Citizen Way.
- Baptist Collegiate Ministries (BCM) sent out 119 student missionaries and conducted nine mission experiences serving in 10 states and Mexico. These included Chattanooga's Tennessee Baptist Children's Home and "MissionLab" sponsored by New Orleans Baptist Theological Seminary. Twelve salvations were seen through these mission experiences.
- During the fall, the Eagles football team saw over 25 students make decisions for Christ.
- Now in its 36th year, C-N's Appalachian Outreach home repair ministry completed 16 home repair projects in surrounding counties. Its Samaritan House shelter served 29 families from four counties and provided 7,801 meals. The ministry continues to provide numerous meals to families in need during the COVID-19 pandemic.
- The University opened the "Randall O'Brien Veterans Center," which provides a gathering and relaxing space for students, faculty and staff who are veterans.
- Carson-Newman was championed by various rankings including being named a "Best in the Southeast" by Princeton Review and cited a "Christian College of Distinction" by Colleges of Distinction for the sixth consecutive year. The University was named among "Great Colleges to Work For," which was overseen by ModernThink. C-N's online graduate program was ranked No. 2 in the state by U.S. News & World Report. It's registered nursing program was named a top ten program in the state by Registered Nursing.org.
- Carson-Newman's Nursing Department held "Blessing of the Hands" ceremonies during the fall and spring. The event allows faculty members to pray over nursing students prior to them entering clinical care and hands-on patient care.
- The University's Baptist Archives received the Davis C. Woolley Award for Outstanding Achievement in Assessing and Preserving Baptist History. The honor was presented by The Baptist History and Heritage Society and the Association of Librarians and Archivists at Baptist Institutions.

Highlights presented here are possible because of the cooperation of Tennessee Baptists. Some programs, like certain mission trips, are made possible by the underwriting of individual like-hearted supporters.

Harrison-Chilhowee Baptist Academy (dba The King's Academy)

Harrison-Chilhowee Baptist Academy celebrates 140 years as a distinctively Christian school. For the past 26 years, Tennessee Baptist's accredited Christian boarding and day school has operated as The King's Academy. During this recent period enrollment increased 400% and the school budget grew to \$6 million. International students are the academy's most distinctive feature—over 1,050 students from 99 nations enrolled since 1935; an average of 14 countries are represented in the academy student body each year.

The academy faces increasing financial challenges each year, and these difficulties will be further amplified by the COVID-19 pandemic. Staff reductions and major budget cuts were necessary to remain operational for the 2020-2021 school year. Given the socio-economic demographics of academy families, increases in fees translate into enrollment declines, particularly to families who suffered income or job loss due to the pandemic.

Nevertheless, the academy remains focused on its VISION – *Transformed Lives, Empowered by Christ-like Character, Pursuing Academic Excellence and Lifelong Service* – and committed to its MISSION: *The King's Academy inspires and equips students of all cultural backgrounds to fulfill their God-given potential in a nurturing, college preparatory community.*

Matthew Mercer entered his second year as President/Headmaster for the 2019-2020 school year and added many new key staff members to enhance both faculty and administration. The academy experienced significant growth in its international boarding population, largely due to a partnership with WESPN, which assists in connecting students from Brazil and other South American countries with the academy. Approximately 70 students lived in the academy's dormitories for the 2019-2020 school year.

The COVID-19 pandemic brought great challenges. Academy students and staff were on spring break, when the academy's board and administration heeded federal, state, and local recommendations to close campus for in-person instruction. Students and staff were unable to have their usual end-of-year celebrations: field day, class programs, baccalaureate, promotions, etc. Thankfully, through the academy's 1-to-1 initiative, implemented for the 2019-2020 school year, every student in grades 6-12 had their own Chromebook for online learning to complete their academic coursework. Devices were also available for younger students who requested access.

Many of the academy's international boarding students were unable to return to their home countries during the COVID-19 shutdown in March, so they remained on campus to shelter-in-place together. These students received round-the-clock care and ministry from the academy's Resident Life, Food Service, and Maintenance Staff as well as online instruction from academy teachers. While it was a hard time to be away from their families, these students from all over the world bonded as their own unique family unit, creating life-long memories through their shared experience.

Prior to transitioning to online learning, highlights of the 2019-2020 school year include:

- Hosted Social Media Awareness & Responsibility Training for Parents, led by Security Officer David Whaley
- Hosted Elementary STEM Night
- Choir/Drama Department presented *Mary Poppins, Jr.*
- Students participated in annual Speech Contest, Spelling Bee, Geography Bee
- High School Volleyball team competed in TSSAA State Tournament
- High School Girls Basketball finished as runner-up in the TSSAA State Tournament Championship
- Our Class of 2020 was a very high academic achieving class, with most gaining acceptance to their first college choice; Commencement was held July 24, 2020 with limited attendance
- High School Girls Basketball Coach Blake Derrick was named PrepExtra Coach of the Year
- Coach Lincoln Thomas was named Strength and Performance Coach of the Year

It is a distinct privilege for the academy family to partner with and serve alongside Tennessee Baptists in the mission of Christian education.

Tennessee Baptist Children's Homes

Tennessee Baptist Children's Homes welcomes children in hard places with the love of Christ. We are only able to welcome these children into our homes because of the faithfulness of churches, businesses and individuals who have a heart for children and families who are struggling. To those of you who fall into this category, thank you for your prayers, for your service and for sharing your financial resources with TBCH. We are committed as a ministry to operate without the use of government funds relying on God's people to supply the resources necessary to meet the needs of children and families in crisis.

2020 has presented many challenges for all of us. We have lost hundreds of volunteer man hours due to COVID-19. And while the number of churches that support us financially has dropped significantly, other churches have stepped up in their support of the kids. All in all, the Lord has shown His faithfulness to this 129-year-old ministry by providing the necessary resources for us to provide homes for children. We rejoice in the five children who have been born again. Rest assured that TBCH is Christ centered in our approach to dealing with children and their families. We believe Jesus is the ultimate answer to all brokenness and our team unashamedly points people to Him in age appropriate ways.

TBCH has provided **Residential Care** for 85 children so far this year in our on-campus homes. Seventeen of these children have been successfully reunited with their families. TBCH is also committed to assisting those who age out of our program. These **Independent Living** students now transition to our Chattanooga Campus where they receive continued support by our staff and have the opportunity to learn a trade or attend college. We are committed to helping these young people get off to a good start in early adulthood. There are presently ten young people in our Independent Living program.

TBCH's **George Shinn Foster Care** program has served 157 children and has 101 foster homes on our team. Fifteen children have been adopted into Christian families so far this year while 31 children are presently in foster-to-adopt situations! Our foster care staff has also seen 15 children successfully reunify with their families.

The foster home in Oakdale is very close to being ready for children to arrive while our foster home in Kingsport is nearing the completion of being remodeled. We are just beginning the search for a family to live in this home who has the heart for caring for sibling groups of foster children. TBCH is grateful for the churches and volunteers who are helping bring this home back into service!

TBCH's **Family Care** program exists to assist families as they deal with things like addictions, child abuse, and the need for faith-based foster homes. We want to help families learn to cope and find the answers they need by providing consultation and resources. We are also ready to provide training for your church in child abuse awareness and in how to support your own foster and adoptive families. Please call on us and we will be there to help you help children.

Tennessee Baptist Adult Homes, Inc. Report to Associations, 2020

I am most grateful to report to you that we have not experienced a single case of Covid-19 at any of our locations! We have much to be joyful about in this regard. The 2020 Father's Day Offering video expresses my utmost appreciation and gratitude for the men and women who live out their calling to *Show What Love Is* by serving as our home managers. They are the ones to be credited for us weathering the Coronavirus storm.

As a result of Covid-19 we have observed a quarantine in our homes for much of this fiscal year. The inability to accept new admissions, conduct placement interviews, allow visitors, or allow residents to visit their family homes has made this a very difficult year for everyone. Our faith is that, in the long run, our efforts will prove well worth the struggle. One case in any facility will have a cascading effect so we developed plans for each individual resident should anyone contract the virus. Each individual plan is designed according to the family and other resources an individual has at their disposal. We call them "the plans we plan to never use."

I am happy to report that we have sold Williams Ferry Pointe in Lenoir City. The transaction took place in a series of closings from June to October 31, 2020. The sale price for WFP was \$2.7M. These much-needed resources will be used to help us realize a **two-fold vision**.

First, it will allow us to establish a significant endowment that will produce operating income. Our Father's Day Offering has never managed to rise to a level to offset our operating deficit.

Secondly, it is our hope to establish a small senior living community in Humboldt on land we already own where we can provide modest, comfortable retirement living (probably duplexes) for indigent pastors and missionaries who may not be financial able to provide from themselves in retirement. TBAH will own these facilities and rent them on a sliding scale basis. They will be for independent living seniors; we will provide no health care or physical assistance. And, it will be a TBAH in west Tennessee!!

Covid-19 and the sale of Williams Ferry Pointe guaranteed that this past year was not, and next year will not be, ordinary. I am confident, however, thanks to the resources from the sale of Williams Ferry Pointe coupled with the elimination of all expenses associated with the operation of Williams Ferry Pointe, TBAH will be OK through the pandemic and for the foreseeable future. Thanks be to God for his provision!

Thanks, again, for your support and partnership with us. May you all be safe and stay well.

2020 Annual Report to Associations

Since 1938 the Tennessee Baptist Foundation has been of service to Tennessee Baptists and Kingdom causes around the world. The assets under management of the Foundation have grown from \$6,577 to \$156 million during that time. God continues to bless this ministry and we are pleased to make our report to the associations as to highlights for the fiscal year 2019-20 thus far. The Foundation is pleased to offer the following services to Tennessee Baptists:

- ◆ Presenting informational Faith-based estate planning seminars for churches
- ◆ Working with individuals, helping them develop distinctively Christian personal estate plans
- ◆ Assisting individuals in their establishment of various Charitable Trusts
- ◆ Serving as Trustee of trusts and funds committed to its care
- ◆ Providing investment services to Tennessee Baptist churches, associations and institutions
- ◆ Helping churches establish Legacy Ministries
- ◆ Facilitating loans to Tennessee Baptist churches/associations
- ◆ Providing grants for qualifying new ministries and projects

Highlights of the Foundation's stewardship thus far for this fiscal year include:

- ✓ Funds under management: Over 1,100
- ✓ Assets under management: \$156,413,916 (as of May 31, 2020)
- ✓ New fund additions as of May 31, 2020: \$2,763,360 (11 new funds)
- ✓ Educational scholarships: 228 - totaling \$184,748 for 2020-2021 academic year. (Awarded over \$5.7 million in scholarships since 1987)
- ✓ Special Project Grants: \$118,300 distributed to assist 67 ministry projects thru May 31, 2020. This included helping 55 churches/associations during the Covid-19 pandemic and \$10,000 to Disaster Relief for tornado relief that affected Nashville in March.
- ✓ Cooperative Program: \$316,965 as of May 31, 2020. Projected to give over \$500,000 by year end.
- ✓ Baptist and charitable causes: \$1,945,310 as of May 31, 2020. Projected to give over \$3.3 million by year end.

The Tennessee Baptist Foundation continues its commitment to manage funds with integrity and help Tennessee Baptists leave legacies with a Kingdom focus.

Tennessee Woman's Missionary Union 2020 Annual Report

In 2019-20, Tennessee WMU continued to challenge Tennessee Baptists in their unshakable pursuit to know God more, show His love unconditionally, and make disciples who make disciples. This report shares information about some of the state events, ministries, and initiatives that have taken place.

Last fall, 698 children and leaders attended three regional JAMs, a missions event for children in grades 1-6 and leaders. Children learned what it means to go everywhere and tell the Good News to everyone, they met missionaries from around the world, and they collected 149 Christmas Backpacks.

Over 500 boys and leaders attended the 2019 RA Camp-O-Ree at Linden Valley Baptist Conference Center on October 18-19. This missions camping event for boys grades 1-12 is hosted by Mid-South Royal Ambassadors and Tennessee WMU. Boys participated in a multitude of activities, challenges, and crafts while enjoying the great outdoors, meeting missionaries, and enjoying two action packed worship services.

Missionary Parents Fellowship Retreat: On September 6-7, 2019, 40 parents of IMB missionaries gathered with program personnel for fellowship, information, prayer, and encouragement at the TBMB Church Support Center in Franklin. The retreat attendees were encouraged to return to their churches and thank them for their support of the Tennessee Missionary Parents Fellowship through gifts to the Golden Offering for Tennessee Missions.

Christmas Checks – In December 2019, Tennessee WMU mailed Christmas Checks, on behalf of Tennessee Baptists to missionary kids and retired missionaries.

- Checks for \$150 were sent to 20 missionary kids whose parents serve with IMB from Tennessee.
- Checks for \$50 were sent to 104 retired IMB missionaries born in Tennessee.

These gifts are made possible through an allocation from the Golden Offering for Tennessee Missions for nurturing Tennessee missionaries and their families.

In the Spring of 2020, concerns about Covid-19 virus were growing and several 2020 events had to be cancelled like Get-Together & Connection, Tennessee WMU Annual Meeting, and RA Wilderness Challenge. Out of the challenges and changes arose some new ways to utilize digital resources:

- Zoom with a Missionary – scheduled Zoom meetings with missionaries and children/youth missions discipleship groups hosted by Tennessee WMU.
- LeaderConnect – Zoom meetings for missions and ministry leaders for training and networking.
- Facebook Pages and Groups – New Facebook groups were started for targeted missions and ministry leaders to coincide with efforts to utilize all Tennessee WMU Facebook groups and pages to network and resource leaders and participants more.

In March 2020, \$34,200 in scholarships were awarded to 29 students attending graduate school, seminary, as well as, undergraduate schools in Tennessee during the 2020-21 school year. These scholarships are funded through endowments, invested funds, and the Golden Offering for Tennessee Missions.

As part of Tennessee WMU's Denver Prayer Advocacy Partnership, over the past three years, 24 ladies have served through six mission teams to Denver. The teams worked with 14 different church planters to prayer walk and engage the communities surrounding the church plants. The two teams scheduled to go in April and May of 2020 had to be cancelled. In June, we partnered with Dave Howeth, NAMB Send Denver Missionary to host three virtual prayer walking tours. Each virtual prayer tour was two hours and participants heard from and prayed for four church planters. There were 47 total participants from 41 churches who participated in one or more prayer tours.

MK Re-Entry Retreat –Two missionary kids from Tennessee were provided travel assistance funds to attend the MK Re-Entry Retreat in Indiana during August 2020 hosted by Indiana WMU, Kentucky WMU, and the International Mission Board.

Literacy Missions ministries are helping bring Tennesseans to Christ. There are 68 “registered” churches/associations English as a Second Language (ESL), Adult Reading & Writing (ARW), or Tutoring Children & Youth (TCY) ministry sites. These sites reported having participants from more than 25 countries, speaking 11 different languages who are being taught English and are engaged with the gospel.

Christian Women’s Job Corps and Christian Men’s Job Corps are ministries of WMU that seek to help men and women break the cycle of poverty through job and life skill classes, Bible study, and mentoring. Last year the 21 sites in Tennessee reported serving 2,855 participants. There were 182 men and women who completed the program and 32 recorded professions of faith.

Missionary Houses in Mt. Juliet – Mary’s House (WMU House) and the Missions Mobilization Center (MMC) House continue to be a hub of activity as they provide a place for our missionaries to rest and reconnect with family and friends. The Worthy family arrived at Mary’s House in June 2020 and will stay through May 2021. Frank & Sheri Moran arrived at the MMC House in April 2020 and will stay through October 2020 unless they receive clearance sooner to return to the mission field; delay due to Covid-19 restrictions.

The theme for the 2019-20 Tennessee Missions Emphasis was “See Tennessee, Go Harvest.” The suggested dates for the Week of Prayer for State Missions were September 13-20, and the goal for the 2019-20 Golden Offering for Tennessee Missions was \$2,100,000. As of July 23, 2020, the total amount given to the 2019-20 Golden Offering is \$1,859,608.48. The offering year goes from September 1 – August 31.

Currently, Tennessee WMU staff includes Vickie Anderson, Executive Director-Treasurer; Denise Bronaugh, Adult Missions & Ministries Specialist; Kim Cruse, Missions Discipleship Specialist; *vacant*, WMU Communications Specialist; Janice Carter, Compassion Ministries Catalyst - CWJC/CMJC, Vickie Clemons, Administrative Assistant; Jacki Holleman, Ministry Assistant; Brian Holt, RA/Challenger State Coordinator; and Tika Soles, Women’s Ministry State Coordinator.

MISSISSIPPI RIVER MINISTRY (MRM)

Mississippi River Ministry (MRM) is one of three arms of the Compassion Ministry outreach of the Tennessee Baptist Mission Board. Like so many of the ministries of the TBMB, COVID took its toll on the activity of this past year. In spite of limitations imposed by the pandemic, Mississippi River Ministry was able to minister in the following ways:

- During this past year, \$5,480 of GOTM funds were channeled into three different West Tennessee associations to assist churches with six different projects and ministries designed to impact lostness by touching poverty.
- Seven (7) poverty training events were conducted. The training events took place in all seven Harvest Fields across the state and 174 participants took part.
- Over 1,700 Christmas backpacks were collected and distributed to ministry sites in West Tennessee last year. Christmas backpacks are still needed for distribution this year. Be sure to check the website at: <https://www.tnbaptist.org/backpacks>.
- Ministry items were collected and delivered to those able to distribute them directly to those in need.

This year marks the 20th anniversary of my work with Mississippi River Ministry. It has been a fruitful and joyful 20 years. As we look ahead to the changes in how Compassion Ministry will be conducted in this Post-COVID world, I am stepping aside and retiring at the end of this year. The commitment on the part of the TBMB will continue to be steadfast in the area of Compassion Ministry as they face the new needs that will arise due to this pandemic. Please be in prayer for what that ministry will look like.

NORTH AMERICAN MISSION BOARD REPORT - 2020

Since 2011, we have seen an increasing number of churches and individuals become more directly involved in church planting and other missions efforts through our **Send Network** and **Send Relief** strategies. These efforts revolve around the priority of **planting new evangelistic churches**—especially in the unreached and underserved areas such as large cities and regions outside the South— and engaging **communities with the gospel through compassion ministry**.

To help Southern Baptists close this gap, NAMB has identified more than **30 focus areas** that are receiving intense church planting and compassion ministry efforts. These areas have vast influence in their regions and beyond. In reaching these strategic focus areas, Southern Baptists can lead many to Christ in North America and around the world.

While NAMB focuses ministry in these different areas, NAMB partners with Southern Baptists to plant churches everywhere for everyone and serve communities everywhere, meeting needs and changing lives.

Send Network Missionaries

Our ***Send City Missionary*** in each **Send City** is there to recruit church planters and help local Southern Baptists develop a plan for reaching the city. He also assists churches and individuals from outside the city who want to partner in efforts to reach the city.

In addition to our City Missionaries, ***Church Planting Catalysts*** (CPCs) are responsible for catalyzing the planting of churches throughout North America. Each is to help bring about the planting of at least four churches annually as well as encourage recently started churches in their region.

In an average year, 1,000 churches disappear from the SBC database. Many of those churches are closing their doors forever. Because of this, we have also prioritized our church revitalization efforts in order to help existing churches become healthier.

Another option for churches is NAMB's **Church Replant initiative**. A replant occurs when a church that's either died or is near death decides to launch a new church from a building that once housed an SBC church. A replant brings new spiritual life. The process allows property to remain in the SBC family as the Replant takes the torch and continues the mission of reaching the community.

Over the last few years, NAMB has developed a **Church Planter Pathway** which is designed to help future church planting missionaries follow God's calling and benefit from the influence of others in the church. From coaching to training, the Pathway cultivates their ability to lead in the process of planting.

In 2019, we sent more than \$27 million to Canadian and state convention partners to fund missionaries and support evangelistic church planting, evangelism and church revitalization ministries in their states.

Establishment of New Congregations

There are nearly 5,000 churches involved in our Send Network strategy as prayer partners or as active participants connected with a ministry location or church planter. In 2019 (the most recent year for which data is available), Southern Baptists planted 552 new churches, 297 new churches affiliated with the SBC and 59 church campuses were launched. To better understand and assess the status of churches in the SBC, new church campuses began to be tabulated in 2019. Altogether, Southern Baptists added 908 new congregations in 2019.

NAMB continues to work with state conventions, associations and churches to deploy church planters, including streamlining the assessment process to get planters on the field quickly without sacrificing the quality of their training. Through NAMB's request and application process, churches, associations and state conventions are able to easily provide a missionary request and NAMB works to match prospective candidates with the request.

During 2019, NAMB provided multiple church revitalization and Replant **gatherings and labs**. In 2020, we will continue to partner with state conventions and offer several more of these **events, both in person and virtually**.

Evangelism

In 2018, Johnny Hunt joined the NAMB team to serve as the senior vice president of evangelism and leadership. Hunt revamped and energized NAMB's evangelism efforts, primarily through the **Who's Your One** campaign and tour. Shane Pruitt joined NAMB's evangelism team in 2019 as the executive director for next gen evangelism.

Overall, 25,827 kits, 411,672 prayer guides and 1.5 million bookmarks were distributed along with 469 kits, 9,228 prayer guides and 70,475 bookmarks produced in Spanish. Through social media, Who's Your One garnered 6.9 million impressions, 828,000 engagements and 16,300 users engaged across all of NAMB's social channels.

Appointment and Support of Missionaries

NAMB supports 3,057 missionary units in varying ministry categories. (NAMB counts missionaries as units. In addition, 3,758 Southern Baptist chaplains serve in the U.S. military, in state and federal prisons, hospice, hospitals, disaster relief, as volunteers and in many other settings around the world. NAMB endorses chaplains on behalf of Southern Baptists and helps train and encourage them as they share Christ every day and disciple those who already know Him.
